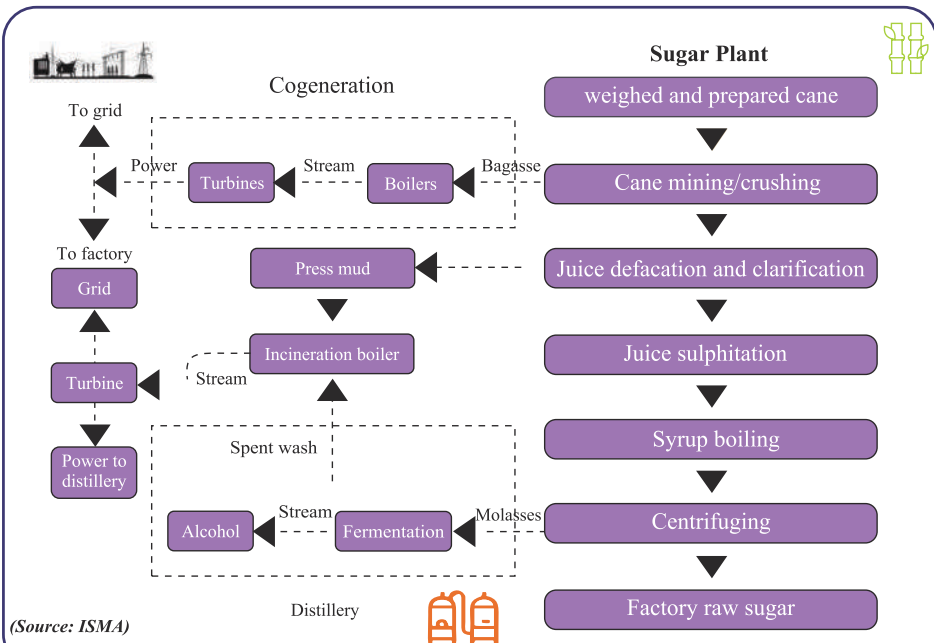
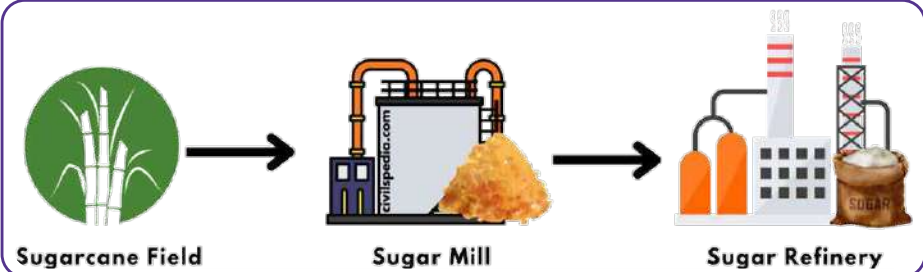

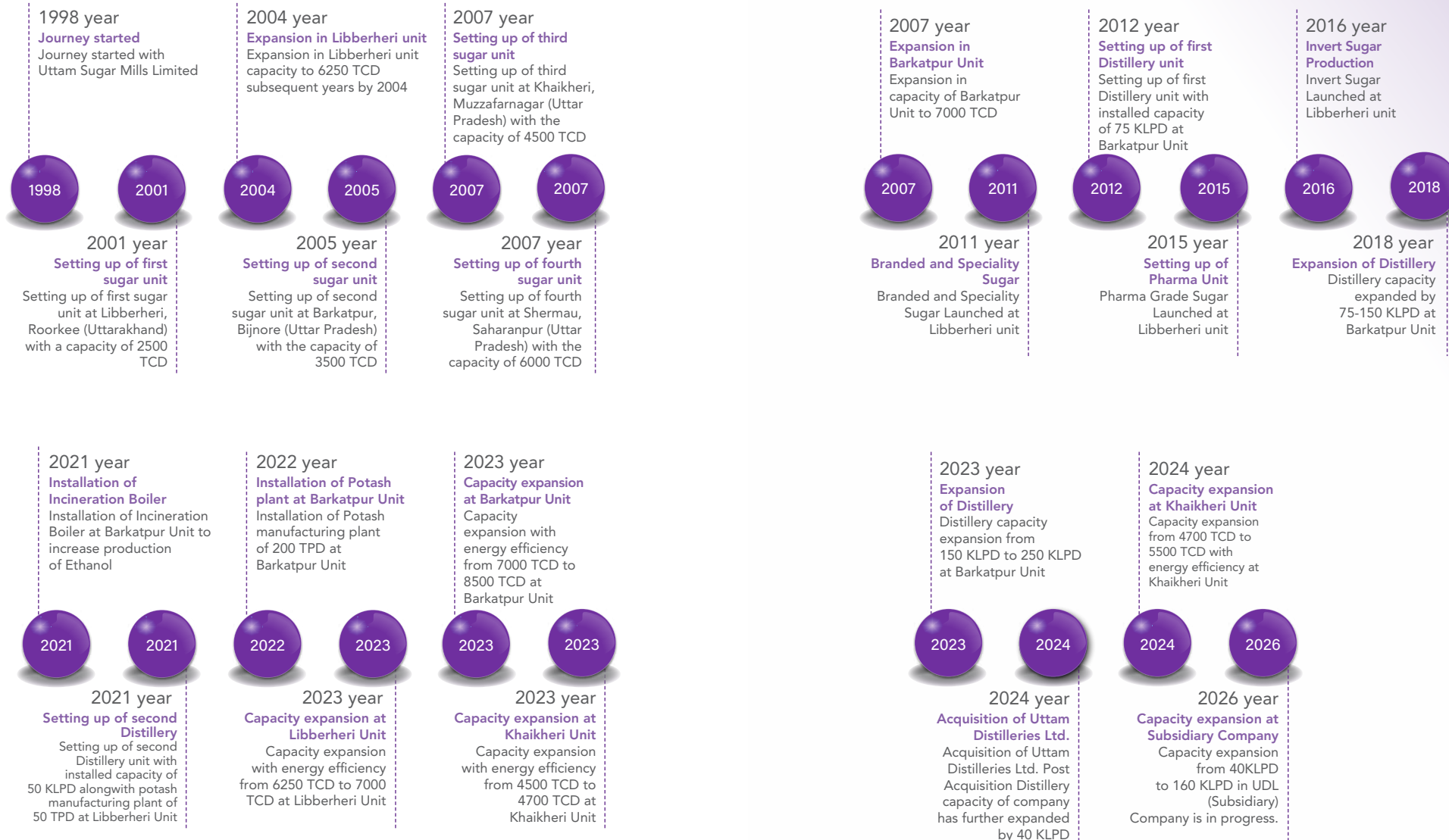

The increase in revenue is mainly on account of better sales realisation of Sugar & improvement in the Distillery Production. EBITDA, during the F.Y 2025-26 is ₹ 22,758 Lakhs as compared to the Previous year EBITDA of ₹ 22,232 Lakhs.

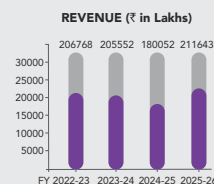

Why is this measured?

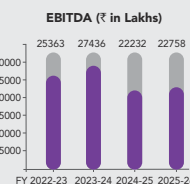
It is an index that measures the Company's ability to report revenue growth, which can, in turn, help the Company amortise expenses effectively, strengthening margins.

Why is this measured?

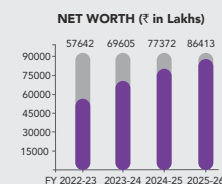
It is an index that showcases the Company's ability to generate a surplus following operating costs.

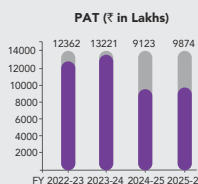

FY 2025-26 was another year of steady growth for the Company. Backed by higher operational efficiency, improved production performance, and prudent financial management, the Company reported 17.55% growth in Total Revenue and 17.67% growth in Revenue from Operations. EBITDA increased by 2.37%, highlighting the Company's continued focus on operational excellence and cost optimization.

Despite a challenging business environment, the Company achieved growth in profitability, with Profit Before Tax and Profit After Tax increasing by 7.23% and 8.23%, respectively. Earnings Per Share (EPS) also improved by 8.24%, reflecting the Company's commitment to delivering consistent returns and enhancing shareholders value.

FY 2025-26 marked another year of robust operational performance for the Company. Supported by a committed workforce of 3,197 employees and strong partnerships with over 1.02 lakh sugarcane farmers, the Company efficiently crushed 327.39 lakh quintals of sugarcane, resulting in the production of 30.68 lakh quintals of sugar and 877 lakh bulk liters of industrial alcohol.

In line with its commitment to sustainable and inclusive growth, the Company also incurred ₹3.19 crore towards Corporate Social Responsibility initiatives, creating a positive impact across the communities in which it operates.



The Company continued to focus on cane development activities, comprising of varietal replacement with proven high sugared varieties, change in pattern of sowing, ratoon management, encouraging use of Bio – fertilizers, Bio- pesticides, soil testing activities, crop protection etc. and modern agricultural practices due to which the recovery is improved. However, due to impact of excessive rains and floods, crop, damaged, resulted in lower crushing. The company is further strengthening the cane development activities by way of development of in-house agri research centre, integrated pest management programme, soil testing facilities, encouraging use of Bio-fertilizer, installation of Lab and Bio-pesticides and training facilities for the farmers & cane development staff.

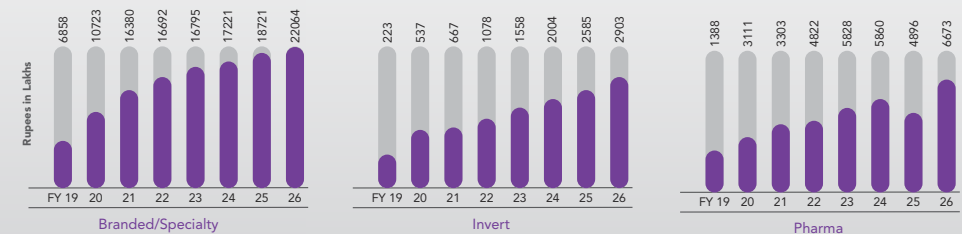

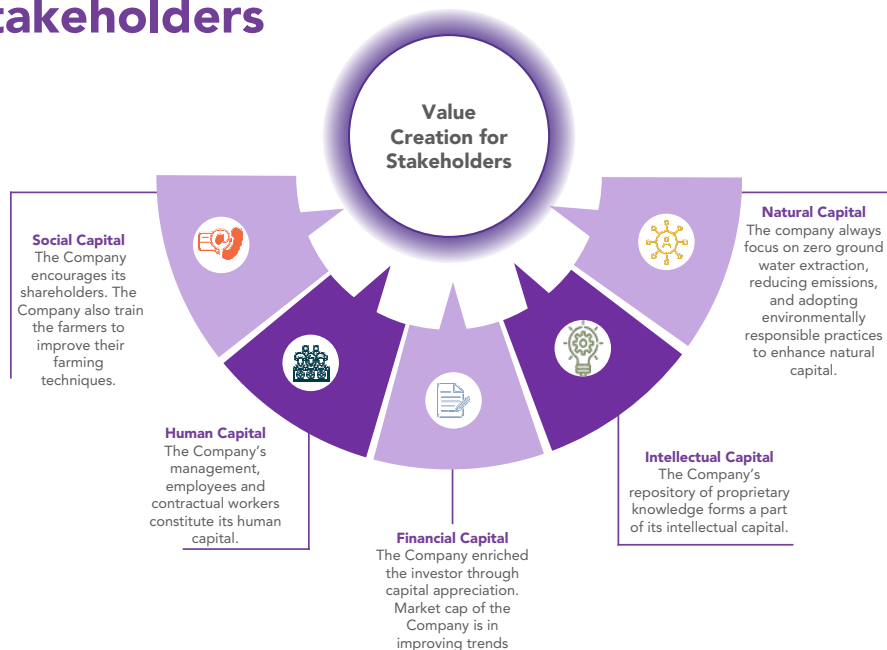

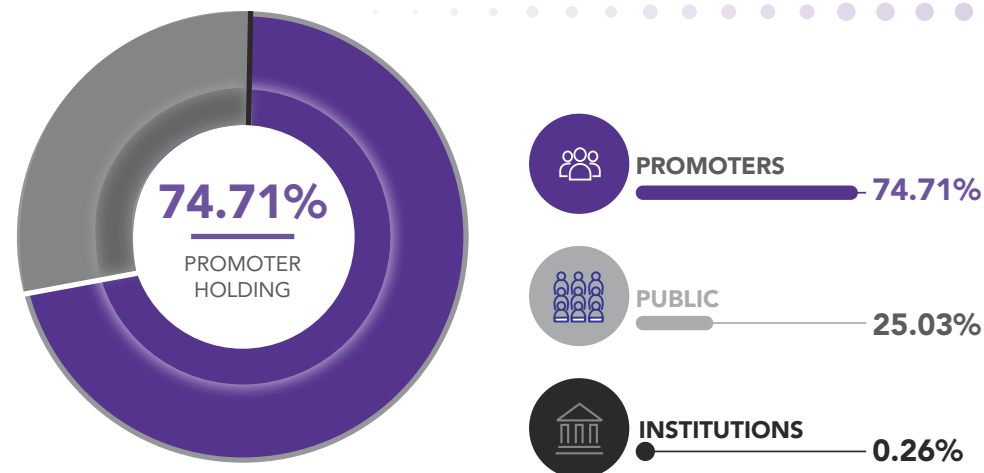

Hence members are requested to update the mobile no./ email ID with their respective depository participants.

- i. Total dividend amount to be received by them during FY 2026-27 does not exceed ₹ 10,000/-

- ii. **Mutual Funds:** Self-declaration that it is registered with Securities and Exchange Board of India ('SEBI') and is notified under Section 11 of Schedule VII [Table Sr. No. 20] of the Act along with self-attested copy of PAN card and certificate of registration with SEBI.
- iii. **Alternative Investment Fund (AIF):** Self declaration that its income is exempt under

Section 11 - Schedule V [Table Sr. No. 1] of the Act, and they are registered with SEBI as Category I or Category II AIF along with self-attested copy of the PAN card and certificate of AIF registration with SEBI.

- iv. **New Pension System (NPS) Trust:** Self declaration that it qualifies as NPS trust and income is eligible for exemption under Section 11 of Schedule VII [Table Sr. No. 41] of the Act and being regulated by the provisions of the Indian Trusts Act, 1882 along with self-attested copy of the PAN card.
- v. **Other Non-Individual Shareholders:** Self-attested copy of documentary evidence supporting the exemption along with self-attested copy of PAN card.

II. For Non-Resident Shareholders:

- a. Taxes are required to be withheld in accordance with the provisions of Section 393(2) [Table Sr. No. 15 and 17] of the Act as per the rates as applicable. As per the relevant provisions of the Act, the withholding tax shall be at the rate of 20% (plus applicable surcharge and cess) on the amount of dividend payable to them. - iii. E-filed Form 41 (filed electronically on the Indian Income Tax web portal pursuant to Notification no. 03/2022 dated July 16, 2022) valid for the period April 2026 to March 2027.
- iv. Self-declaration by Shareholder of meeting treaty eligibility requirement and satisfying beneficial ownership requirement. (For FY April 1, 2026 to March 31, 2027).
- v. In case of Foreign Institutional Investors and Foreign Portfolio Investors copy of SEBI registration certificate.
- vi. In case of Shareholder being tax resident of Singapore, please furnish the letter issued by the competent authority or any other evidence demonstrating the non-applicability of Article 24-Limitation of Relief under India-Singapore DTAA.

It is recommended that Shareholders should independently satisfy their eligibility to claim DTAA benefit including fulfilling of all the conditions laid down by DTAA. Kindly note that the Company is not obligated to apply beneficial DTAA rates at the time of tax deduction / withholding on dividend amounts. Beneficial rate as per DTAA for the purpose of withholding taxes shall depend upon completeness and satisfactory review by the Company of the documents submitted by the non-resident Shareholder.

Lower withholding as per Certificate under Section 395: In case, shareholders (resident or non-resident) provide certificate under Section 395 of the Act, for lower / nil withholding of taxes, rate specified in the said certificate shall be considered, on submission of self-attested copy of the certificate. Please note that Shareholders should seek the lower withholding certificate on the TAN of the Company to enable the Company to grant the benefit of the lower withholding certificate. 'SWAYAM' is a secure, user-friendly web-based application, developed by the Company's RTA, that empowers shareholders to effortlessly access various services. Shareholders may register on the aforesaid portal to avail the services.
17. The shareholders holding shares in physical form are mandatorily required to update their KYC viz. PAN, address, contact details, specimen signatures, in prescribed forms and with supporting documents, before commencing any service request. Post updating the KYC all outstanding dividends are released directly into the bank account electronically.
18. SEBI vide Circular Nos. SEBI/HO/OIAE/OIAE_IAD-3/P/CIR/2023/195SEBI/HO/OIAE/OIAE_IAD-3/P/ CIR/2023/195 dated 28th December, 2023, read with earlier circulars issued in this regard, has established a common Online Dispute Resolution Portal ('ODR Portal') for resolution of disputes arising in the Indian Securities Market. Pursuant to the said circulars, post exhausting the option to

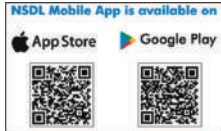

PERFORMANCE OF THE COMPANY

REVENUE FROM OPERATION during the year under review, your Company's Revenue from Operations was ₹ 2,11,025.82 Lakhs as compared to ₹ 1,79,340.97 Lakhs in the previous financial year.

EBITDA during FY 2025-26 is ₹ 22,757.76 lakhs as compared to ₹ 22,231.53 lakhs during the previous FY, EBITDA is higher as compared to previous FY is mainly on account of better sales realization of sugar and improve

in the distillery production and sugar recovery besides increase in SAP of Cane by ₹ 30/-Qtls and lower crush due to damage in crop on account of excessive rains & floods.

Earning before tax is at ₹ 13,278.64 lakhs as against ₹ 12,383.43 lakhs in previous financial year.

Earnings after tax is at ₹ 10,002.61 lakhs, as compared to the earnings after tax of previous FY of ₹ 9,041.16 lakhs.

Major Highlights of FY 2025-26 and of SS 2025-26

- During the FY 2025-26, company sold 36.80 Lakhs Qtls sugar as compared to the 32.85 Lakhs Qtls in the previous financial year.
- During the FY 2025-26, company sold 847.02 Lakhs bulk litres industrial alcohol (Ethanol/ENA) as compared to the 675.38 Lakhs bulk litres in the previous financial year.
- Revenue from operation in FY 2025-26 increased by around 17.67% from ₹ 1,79,340.97 lakhs to ₹ 2,11,025.82 lakhs. The increase in revenue is mainly due to increase in quantity of sugar & ethanol and better sugar realization.
- During the FY 2025-26, the EBITDA margin on total income has decreased from 12% to 11% on total income mainly on account of increase in SAP of Sugarcane. However, EBITDA is higher at ₹ 228 crores as against ₹ 222 crore in previous year.

- Sugarcane crushing in SS 2025-26 decreased by around 25% from 401.68 lakhs Qtls to 301.51 lakhs Qtls. The decreased in crush is mainly due to yield effected due to heavy rain / flood and unfavorable weather conditions.

- Net Recovery of Sugar during the season was 9.42% in SS 2025-26 as against 8.94% in SS 2024-25 with B Hy molasses/syrup. Recovery equivalent to C Hy molasses slightly higher at 11.35% in SS 2025-26 as against 11.28% in SS 2024-25.

- During the sugar season 2025-26 5.82 Lakhs (1.93%) qtls of sugar diverted to ethanol as compare to 9.42 lakhs (2.34%) qtls during SS 2024-25 in the form of B Hy & syrup.

- During the current season our 03 units of UP operated through B Hy molasses besides Barkatpur also operated on syrup with B Hy molasses & Libberheri operated on B Hy & C Hy molasses.

- Alcohol production of 877 lakhs BL in FY 2025-26 as against 666 lakhs BL in FY 2024-25, an increase of 32% over previous year.

The Company registered a gross turnover of Sugar of ₹ 1,52,595.33 Lakhs for the year ended 31st March, 2026 as against ₹ 1,31,093.95 Lakhs for the year ended 31st March, 2025— an increase of gross turnover by 16% because of increase in sales quantity by 12% and the net sales realization of Sugar was better at ₹ 4143 per qtl during Current year as against ₹ 3984 per qtl in previous year.

During the current season, the Company commenced its crushing in all 04 Units in 1st week of November 2025. The sugar recovery was slightly on higher side as compared to previous season.

The Company's aggregate sugar cane crushing was 301.51 Lakhs qtls during the season 2025-26 as against 401.68 Lakhs qtls during the season 2024-25. The decrease in cane crush is due to yield effected due to heavy rain / flood and unfavorable weather conditions.

The Company continued to focus on cane development activities, comprising of varietal replacement with proven high sugared varieties, change in pattern of sowing, ratoon management, encouraging use of Bio – fertilizers, Bio-pesticides, soil testing activities, crop protection etc. and modern agricultural practices due to which the recovery and crushing is expected to improve in the coming season. Apart from these activities, company is further strengthening the cane development activities by way of development of in-house agri research centre, integrated pest management programme, soil testing

facilities, encouraging use of Bio-fertilizer, installation of Lab and Bio-pesticides and training facilities for the farmers & cane development staff.

- There is increase in cane price of SS 2025-26 by ₹ 30/- Per qtl in both states i.e. Uttar Pradesh & Uttarakhand SAP for SS 2025- 26 were as under: -

- Society Commission remain same as it was in previous season at ₹ 5.50/- qtl for Sugar Season 2025-26 in both the states.
- For the sugar season of 2026-27, FRP increased at ₹ 365/quintal for a basic recovery of 10.25%. Providing premium of ₹ 3.56/- qtl. For each 0.10% increase in recovery over and above 10.25% & reduction in FRP by ₹ 3.56/- qtl. For each 0.10% decrease in recovery.
- Govt. has restricted export of sugar with effect from 13th May till 30.09.2026.

Co-generation Division

During the period under review, your company produced 2,175 Lakhs KWH of power as compared to 2,267 KWH

of power in the year 2024-2025. Out of total production, your company exported 1,006 Lakhs KWH to UPPCL/ UPCL for a total amount of ₹ 5,717 Lakhs against 1,046 Lakhs KWH for an amount of ₹ 4,636 Lakhs in the previous year. Power Production/Export decreased mainly due to lower cane crush.

Distillery Division

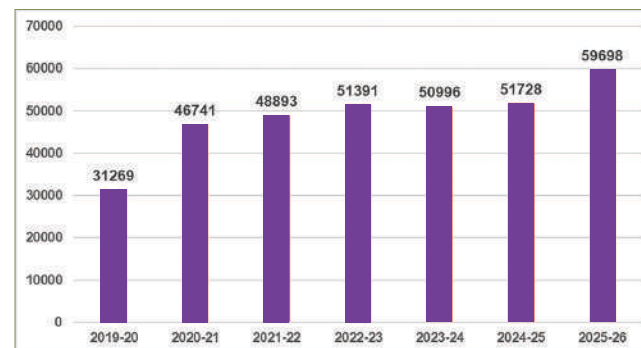
Your company has two Distilleries with an installed capacity of 300 KLPD. (250 KLPD at Barkatpur (Distt. Bijnor) in the State of Uttar Pradesh and 50 KLPD Libberheri (Distt. Haridwar) in the State of Uttarakhand on the working of C Hy. In case of plant operate on B Hy/Syrup, capacity will further be higher by 25%.

During the year under review 876.89 Lakhs bulk litres (BL) of industrial alcohol produced as compared to 665.57 Lakhs bulk litres in the year 2024-25 and your company sold 847.02 Lakhs bulk litres industrial alcohol (including of Ethanol) as compared to the 675.38 Lakhs bulk litres in the previous financial year.

CO2 gas sold of 55.54 Lakhs kg amounting to ₹ 140 Lakhs during the Year as compared to sales of 49.01 Lakhs kg amounting to ₹ 135 Lakhs in the previous year ending 31st March 2025.

During the year under review 71.99 lakhs KG of Potash amounting ₹ 79 lakhs sold as against 66.22 lakhs KG amounting ₹ 100 lakhs in previous financial year.

Company is continuously focusing in the sales of specialty products consisting of sachet, icing, invert, cubes (both white & brown) etc. New major buyers added in HORECA sector like IRCTC, CCD, Starbucks, Mother Dairy, Flipkart, Blinkit, Zepto etc.

The Indian Sugar Season 2025-26 was characterized by few landmark statistics such as-

- a) As of 31st May 2026, around 276.00 Lakh Qtls sugar produced which is higher by 7% as compare to previous SS 2024-25. The state wise details are as follows:

- b) Major increase in sugar production, were observed in state of Maharashtra by 23% and Karnataka by 19%.
- c) Despite a minor 4% contraction, UP remains a massive pillar of the industry, standing comfortably as the second-largest producer.
- d) Maharashtra has overtaken Uttar Pradesh to become the single largest producer in the country for this period. Its massive 23% jump is the primary engine behind the nationwide growth.
- e) Karnataka holds a strong third place, showing a significant 19%.
- f) As of April 30, 2026, around 514 Crore Litre of ethanol has been supplied to the OMCs. Out of which, the sugar sector has contributed around 182 crore liters of ethanol and around 332 crore liters has been contributed by the Grain sector.
- g) Overall, the percentage-wise contribution of the Sugar Sector and Grain Sector stands at around 35% & 65%, respectively. The blending percentage of

19.99% was achieved on the corresponding date by blending of around 543 crore ltrs. Sugar diversion towards ethanol has been estimated around 23 lakh tonnes till April 30, 2026.

- h) In line with Excise Duty exemption on E20, to encourage the Ethanol blending Program exemption extended to E22, E25, E27 & E30.
- i) Notifying the E22, E25, E27 & E30 by BIS, the demand will further be improved.
- j) Government of India has prohibited sugar exports with immediate effect from 13th May, 2026 in view of lower sugar stock.
- k) State Advised Price (SAP) of UP & UK states of sugarcane for the sugar season 2025-26 has increased by ₹ 30/-Qtls. The new SAP of UP & UK is ₹ 400 & ₹ 405.00 per quintal respectively for early variety of sugarcane. In case of general variety, it is lesser by ₹ 10/-qtl.
- l) Fair and Remunerative Price (FRP) of sugarcane for sugar season 2025-26 (October - September) at ₹355/qlt for a basic recovery rate of 10.25%, providing a premium of ₹3.46/qlt for each 0.1% increase in recovery over and above 10.25%, & reduction in FRP by ₹3.46/qlt for every 0.1% decrease in recovery.
- m) Fair and Remunerative Price (FRP) of sugarcane for Sugar Season 2026-27 (October - September) at ₹365/qlt for a basic recovery rate of 10.25%, providing a premium of ₹3.56/qlt for each 0.1% increase in recovery over and above 10.25%, & reduction in FRP by ₹3.56/qlt for each 0.1% decrease in recovery.
- n) Closing stock estimated around 4.25 million MT at the end of sugar season 2025-26.
- o) The intervention of the Government needed for the industry with respect to MSP which needs to be increased from ₹ 3100/- qtl as cost of production is very high as compare to MSP.

The Indian Ethanol industry review

India's ethanol industry has transformed from a relatively small sugar-industry by-product business into a strategic energy sector driven by the government's Ethanol Blended Petrol (EBP) Programme. The country has achieved approximately 20% ethanol blending in petrol ahead of its original target, making India one of the world's fastest-growing biofuel markets.

The sector has benefited from strong policy support, rising production capacity, and increasing participation from both sugar-based and grain-based ethanol producers. However, the industry is now entering a more complex phase marked by overcapacity concerns, feedstock

diversification, pricing challenges, and uncertainty regarding post-E20 growth.

India has begun rolling out auto fuel blended with 85% ethanol (E85) to encourage wider adoption of environment-friendly fuel in the country as well as reduce dependence on imported crude oil.

E85 contains 80% to 85% ethanol and 14% to 19% petrol and is specifically designed for use in flexible-fuel vehicles capable of operating on ethanol blends ranging from E20 to E100, the Ministry of Petroleum and Natural Gas said in a statement on 5 June.

E85 will initially only be available at 48 fuel pumps run by state-owned oil marketing companies, but will soon be expanded to cover the entire country,

In the first phase, E85 will be available at outlets across the national capital region including New Delhi, and Mumbai, Pune and Nagpur in the western Maharashtra state, a petroleum ministry official said.

The initiative "would be scaled up to 500 fuel stations by December 2026 and about 5,000 fuel outlets by December 2027", the petroleum and natural gas ministry stated.

India's automobile industry is on board for the launch of E85 and passenger vehicle producers such as Maruti Suzuki and Hero MotoCorp have already rolled out flex-fuel compatible vehicles, petroleum minister Hardeep Singh Puri said in the statement.

Flex-fuel vehicles are equipped with an internal combustion engine that can run on petrol, ethanol or methanol, or any blend of the two in the same fuel tank.

For regular vehicles, India currently mandates a 20% blend of ethanol (E20) in petrol.

With the expected increased adoption of flex-fuel vehicles, the Indian government hopes to raise India's overall blend to 27% (E27) by 2030.

Speaking at the Sugar, Ethanol & Bio-Energy India Conference in Nagpur, Gadkari said that he had signed the file finalising the regulatory framework for vehicles capable of operating on fuel containing nearly 100 percent ethanol.

The decision clears an important legal and technical hurdle for automobile manufacturers planning to introduce flex-fuel and dedicated high-ethanol vehicles in India. It also signals that the government's ethanol strategy is moving beyond the nationwide E20 programme towards vehicles capable of operating on substantially higher ethanol concentrations.

However, regulatory approval alone will not result in the immediate nationwide availability of E100. Vehicle launches; fuel pricing, ethanol distribution, retail infrastructure and consumer acceptance will determine how quickly the technology moves from demonstration vehicles to mainstream adoption.

Apart from above, Notifying of E22, E25, E27 & E30 by BIS will further boost the Ethanol Blending Programme. Now India is moving to Bio Energy hub.

UPDATE ON THE UTTAM DISTILLERIES LIMITED (SUBSIDIARY COMPANY)

REVENUE FROM OPERATION, during the year under review, your Company's Revenue from Operations was ₹ 10362.20 Lakhs as compared to ₹ 9395.01 Lakhs in the previous financial year.

EBITDA, during FY 2025-26 is ₹1296.16 lakhs as compared to ₹ 102.81 lakhs during the previous FY.

Earning before tax is at ₹ 550.00 lakhs as against ₹ (853.75) lakhs in previous year.

Earnings after tax is at ₹ 485.95 lakhs, as compared to the earnings after tax of previous FY of ₹ (652.08) Lakhs.

Uttam Sugar Mills Limited is holding 83.73% stake in UDL (Subsidiary Company). UDL is a closely held Company and it has 40 KLPD Ethanol/ ENA distillery (installed 48 KLPD) expandable upto 160 KLPD Ethanol / ENA plant based on all types Grains at Bahadarabad, Dist. Haridwar (Uttarakhand). UDL is also taking necessary steps, to expand its distillery capacity from 40 KLPD to 160 KLPD to capitalize on the government's ethanol blending focus and increased production of ENA in the state of Uttarakhand.

Being the Holding Company of UDL, the Company has prepared Consolidated Financial Statements for the year ended 31.03.2026 along with Standalone Financial Statements and the same is annexed with this 31st Annual Report.

A separate statement containing the salient features of financial statements of subsidiary of the Company in the prescribed Form AOC-1 is annexed and marked as "Annexure-I" and forming part of this Annual Report, in compliance with Section 129(3) and other applicable provisions, if any, of the Companies Act, 2013 ("the Act") read with the Rules issued thereunder.

SHARE CAPITAL

The paid-up equity share capital of the Company as at 31st March, 2026 stood as ₹ 38.14 Crores. During the year under review, the Company has not issued any Shares including shares with Differential Voting Rights/ Stock Options/Sweat Equity shares etc. Further, during the year under review the Company had redeemed 60,000, 6.50% Non-Cumulative Redeemable Preference shares and 8,25,000 10.00% Non-Cumulative Redeemable Preference shares as per the terms of the issue.

The Company further redeemed 43,600 6.50% Non-Cumulative Redeemable Preference Shares and 9,000 10.00% Non-Cumulative Redeemable Preference Shares on 10th July 2026, in accordance with the terms of their issue. Consequently, all the outstanding Preference Shares have been fully redeemed, and the Company has no outstanding liability in respect of Preference Share capital.

DEPOSITS

Your Company has not accepted any deposits within the meaning of Section 73 of the Companies Act, 2013 read with Companies (Acceptance of Deposits) Rules, 2014. There were no unclaimed or unpaid deposits at the end of Financial Year i.e. 31st March, 2026.

DIRECTORS / KEY MANAGERIAL PERSONNEL (KMP) Retirement by Rotation

In accordance with the provisions of the Companies Act, 2013 and the Articles of Association of the Company, Mr. Shankar Lal Sharma (DIN: 09018381), Executive Director of the Company is liable to retire by rotation and being eligible, offers himself for appointment. The Board recommends the appointment of Mr. Shankar Lal Sharma as Director in the ensuing AGM of the Company.

Changes in the Board/KMP (Appointment and Resignation)

During the year under review, Mr. G. S. Matta, Non-Executive Non-Independent Director and Mr. Jasbir Singh Non-Executive Independent Director were re-appointed by the shareholders of the Company, at the 30th Annual General Meeting, for a further term of five years commencing from 30th September, 2025 to 29th September, 2030 as per the provisions of the Companies Act, 2013.

Further, Mr. Ravi Kumar (DIN: 02362615) was appointed as Non-Executive Independent Director for a period of five years commencing from 10th August, 2022 to 09th August, 2027. Since, the tenure of Mr. Ravi Kumar will be going to expire on 09th August, 2027, he may be re-appointed for second tenure of 5 (Five) years as an Independent Director. Accordingly, Mr. Ravi Kumar, Non-Executive Independent Director being eligible is proposed to be re-appointed as Non-Executive Independent Director of the Company for the second tenure of 5 (Five) years commencing from 10th August 2027 to 09th August 2032 as per the provisions of the Companies Act, 2013.

- Regarding observation in Para ix (a) of Annexure 'A' and 'Emphasis of Matter' to the Report, it was noted that during the year the company has not accounted for interest on unsecured loan received from the State Government of Uttarakhand amount to ₹ 26.26 Lakh for the quarter and year ended 31st March, 2026 and ₹ 52.52 Lakh upto to 31st March, 2026 (₹ 26.26 Lakh for previous quarter and up to year ended 31st March, 2025). He further added that the Management has clarified to us that the said loan was in the nature of one-time assistance by State Government and no further demand has been made since January, 2008 and the application in respect of waiver of outstanding loan and interest thereon has also been filed with the appropriate authority and it has also been decided by the management to not to provide further interest till the final outcome. It is also confirmed by the Statutory Auditors that this Report has been issued with unmodified opinion.

- We installed steam saving equipment like Falling film evaporators, condensate juice heaters, new sugar melter, Cigar system for heat recovery from flash vapours, mechanical circulators for vacuum pans with modern instrument system to run on fully automatic mode along with field instrument and DCS to reduce steam consumption from 48 to 38 % at USML, Shermau Unit during the season 2025-26.
- We have installed steam saving equipment at our three units viz. Barkatpur. Khaikheri and Libberheri which resulting in a significant reduction in steam consumption and improved overall energy efficiency.
- In order to achieve additional saving of Bagasse, the diversion and application of muddy juice on mills from juice clarifier continued successfully during the season 2025-26 also, which enabled our distillery units to become self-sufficient for their requirement of bagasse as fuel for off season also.
- Power saving devices such as LED in place of Sodium Vapour Lamps, variable frequency drives in place of star delta starter and high mast lighting towers to replace number of traditional lights and bulbs were further installed
- Optimised Motor Loading with the replacement of IE-3 energy efficient Motor in place of IE-2 Motor.
- Maximum VFD replaced in place of D.O.L. starter in all the plants for the saving of Electricity till season 2025-26.
- We have installed additional power saving devices such as variable frequency devices and LT/HT power capacitor bank for power saving in all the plants.

- All the four sugar factories have bagasse based co-generation power plants, partly used for captive consumption and balance being exported to U.P. / Uttarakhand Power Corporation Ltd.

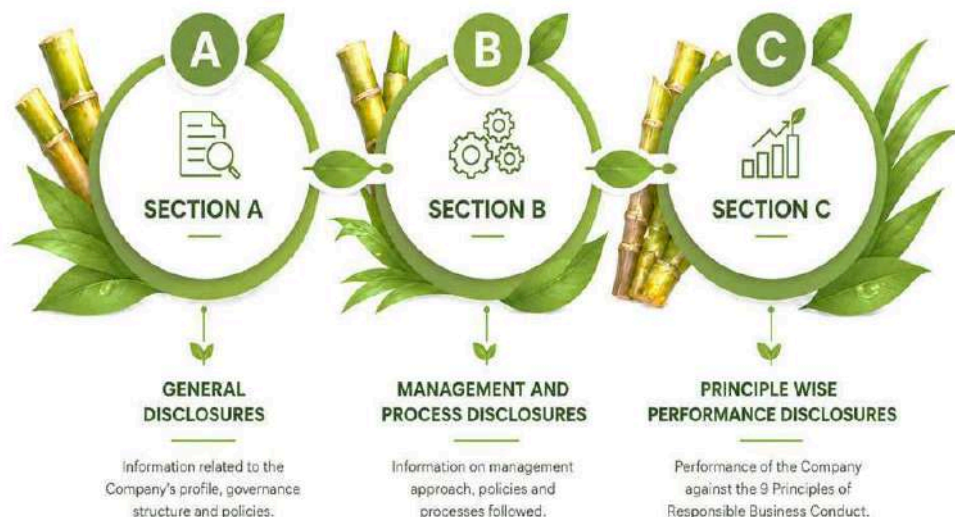

At Uttam Sugar Mills Limited, we have a different range of customers across our different product lines.

Sugar – The Company is engaged in manufacturing of sugar including of Sulphur-less Refined Sugar, Double Refined, packed in small packaging, Natural Brown Sugar, Liquid Sugar, Pharma Sugar, Icing Sugar, Sachet Sugar, Cubes, Candy etc. Our sugar which being produced are regularly matched with NSI standard and norms. Similarly, we are complying and following up all the rules and regulations of FSSAI and our sugar being packed in very hygienic conditions with complying of packaging rules.

Co-gen – Company is having the facility of Bagasse based Co-generation of Power which is a great alternative to Fossil Fuels and reduces the gas emission to safeguard the environment. The Power generation based on Bagasse is a renewal source of Energy. The said power is used for captive consumption as well as surplus power is being exported to Uttar Pradesh Power Corporation Ltd (UPPCL) and Uttarakhand Power Corporation Limited under the Power Purchase Agreement with them.

Ethanol – Molasses is generated as by-product during the manufacturing of Sugar. It is the raw material for manufacture of Industrial Alcohol and Ethanol besides syrup is also being used for manufacturing of Industrial Alcohol. The production of Alcohol and Ethanol is being done at Distillery where the company has ensured Zero Liquid Discharge (ZLD) by the latest process of concentration of Spent Wash through Multi Effect Evaporators and incineration of concentrated Spent Wash through Slop Fired Boilers. Ethanol being supplied to Pubic Oil Marketing Companies for blending with Petrol under the Ethanol Blending Programme (EBP) of Central Government of India. Ethanol is ECO Friendly fuel and helps to save foreign exchange also by reducing import of crude oil.

Liquid Carbon Dioxide and Potash – During the distillery operations, we produced the CO₂ and Potash from the Ash of Incineration Boiler and same being sold.

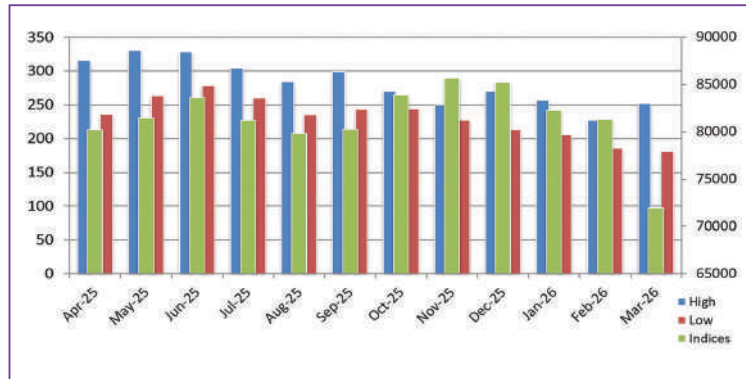

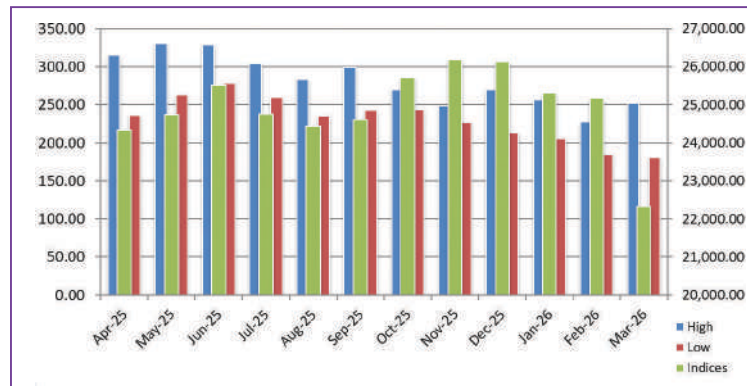

USML SHARE PRICE & BSE SENSEX



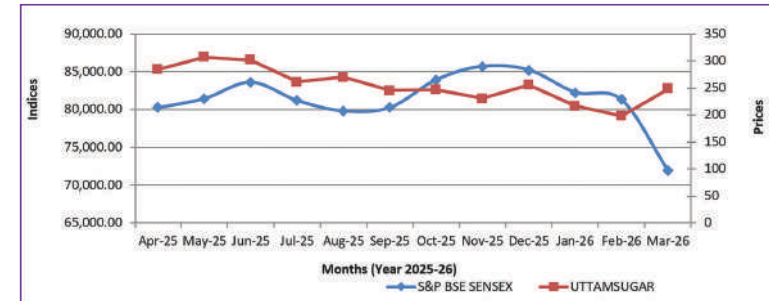

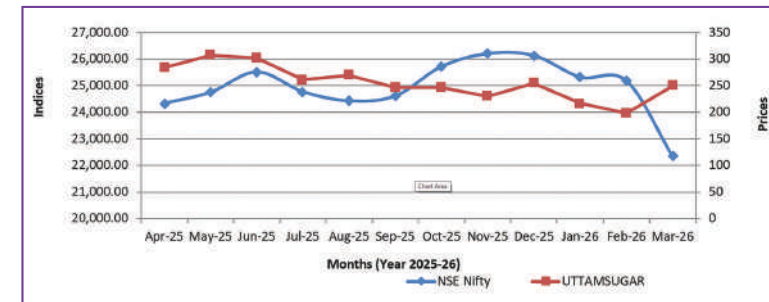

USML SHARE PRICE CNX NIFTY



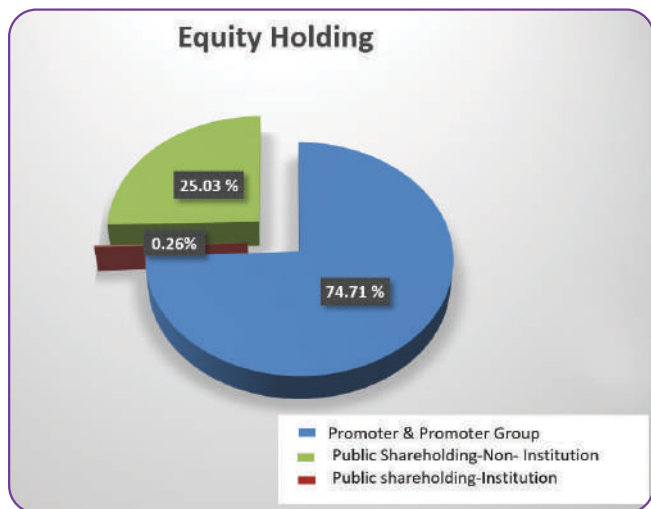

Your Directors are pleased to present its Management Discussion and Analysis Report as per Regulation 34(2) (e) of SEBI (listing obligation of disclosure requirements) Regulations, 2015.

A. GLOBAL ECONOMIC OUTLOOK

The global economy is facing another major shock. The conflict in the Middle East has triggered sharp increases in energy prices, renewed inflationary pressures, and fuelled expectations of tighter monetary policy. Global growth is projected to slow to 2.5 percent in 2026, from 2.9 percent in 2025—the lowest rate since the COVID-19 pandemic—amid weaker prospects for economies dependent on energy imports and those directly affected by hostilities. Activity is expected to firm in 2027–28 as energy supplies recover, monetary easing resumes, and trade strengthens.

Despite many gloomy predictions, the world avoided a recession, the banking system proved largely resilient, and major emerging market economics did not suffer sudden stops.

Growth in emerging market and developing economies (EMDEs) is expected to slow to 3.6 percent this year. For all EMDE regions, growth this year is forecast to be weaker than in 2025. Per capita income growth in EMDEs is projected to slow in 2026 to its weakest pace since the pandemic. The level of per capita income across EMDEs excluding China and India, relative to advanced economies, is not expected to return to the pre-pandemic level until after 2028, implying nearly a decade of lost income convergence.

B. STATE OF THE INDIAN ECONOMY

The Indian economy grew at a better-than-expected 7.8% in the fourth quarter of last financial year 2025-26. The GDP growth for the whole year stood at 7.7% marginally higher than the previous government estimates of 7.6%. India's economic growth has beaten estimates, especially as experts had expected some impact of the US-Iran conflict to reflect in the headline number.

Quarterly sector-wise data showed particularly strong growth in trade, hotels, transport, communication, broadcasting and storage-related services, which expanded 12.5% year-on-year. Financial, real estate and professional services followed with growth of 10.4%. Manufacturing registered an increase of

7.3%, while the construction sector grew by 8.4% during the quarter.

At constant prices, real GDP for the January-March quarter is estimated to have been at ₹ 87.77 lakh crore, compared with ₹ 81.40 lakh crore in the corresponding period of the previous fiscal year. Nominal GDP during the quarter is estimated at ₹ 94.65 lakh crore, reflecting growth of 9.1%.

For FY 2025-26 as a whole, real GDP is projected to reach ₹ 323.12 lakh crore, up from the First Revised Estimate of ₹ 299.89 lakh crore for FY 2024-25. This translates into annual growth of 7.7%. Nominal GDP is estimated at ₹ 346.36 lakh crore, representing an increase of 8.9% over the previous year.

India's growth being driven by strong domestic demand and consistent government spending. These factors have supported stable employment and helped contain inflation, which is expected to full 3.93% (retail inflation rate) and 4.78% (consumer food inflation rate) well within the target of Reserve Bank of India. Financial market is also reflecting this optimism. Stock Indices have shown solid gains, booked by sustained investor confidence.

India's manufacturing performance strengthened with GVA growth of 7.72% in quarter 1 and 9.13% in quarter 2 in FY 2025-26. Medium & high technology industries contributing 46.30% of India manufacturing value added. India's manufacturing output holds steady at approx. \$ 492.98 billion, securing its position in a top five global manufacturing hub. The India government has set an ambition good to increase manufacturing contribution to GDP from the current 17% to 25% by 2030.

Global Sugar Industry Scenario:**World**

Global sugar production is forecast down 1.2 million tons to 181.29 million with lower production in Brazil, the European Union the United States and Thailand expected to more than offset higher India production. Exports are forecast down slightly to 64.32 million tons with reduced exports from Brazil, the European Union, Morocco, and Pakistan more than offsetting higher shipments from Australia. Ending stocks are forecast to rise slightly, primarily in China and India.

Country wise Scenario:

U.S.: production is forecast down slightly to 8.0 million tons. Imports are forecast nearly 600,000 tons higher to 3.0 million based on projected quota programs consistent with World Trade Organization and free-trade agreement obligations, and on projected imports from Mexico, reexports, and higher tariff imports. Consumption is unchanged while stocks are reduced mostly due to lower output.

Brazil: production is forecast down 1.3 million tons to 42.5 million on the expectation that the ethanol/sugar mix will favor ethanol at 52 percent versus 48 percent for sugar. Strong domestic ethanol demand drives the shift in the ethanol/sugar mix following the August 2025 policy change to increase the anhydrous ethanol blend in gasoline from 27 percent to 30 percent. With lower sugar output, consumption and exports are forecast to decline.

China: production is forecast nearly unchanged at 12.7 million tons on normal growing conditions and stable sugarcane and sugarbeet area. The central government continues to prioritize sugar production, with local governments in Guangxi and Yunnan provinces supporting this goal through subsidies and programs that promote improved planting techniques and mechanization. Imports and consumption are expected flat.

European Union: production is forecast to fall 1.2 million tons to 14.4 million on lower sugarbeet area amid weak prices and high input costs, leading some growers to switch to alternative crops. Imports are up with lower production while exports are forecast down and consumption flat.

Thailand: production is forecast down 1.8 million tons to 9.5 million due primarily to reduced area following last year's announcement by the Office of the Cane and Sugar Board to set the farm-gate price below the cost of production to reduce inflation.

Consumption and exports are expected to remain unchanged.

C. INDIAN SUGAR INDUSTRY SCENARIO:

India is the world's second-largest sugar producer behind Brazil and output in 2026/27 is forecast to recover 3.6 million metric tons (raw value) to 33.6 million. Consecutive monsoons restored groundwater reserves, leading to improved yields and increased area. Area planted and harvested are forecast at nearly 6.0 million hectares, a 2 percent increase from the previous year. Uttar Pradesh, Maharashtra, and Karnataka are the leading sugarcane producing states, accounting for nearly 60 percent of total sugar production.

India's sugar industry is highly regulated through a variety of laws and policies designed to balance the interests of growers, sugar mills, and consumers that prioritizes domestic stability over global market trends. Growers are shielded from market volatility by the Fair and Remunerative Price (FRP) mechanism, which establishes a guaranteed federal minimum price paid to growers each year, though several states establish higher prices. The FRP is legally-binding and sugar mills must pay growers within 2 weeks of delivery. Sugar mills cannot sell below an established government price, which allows mills to cover costs and pay the FRP to growers. The government also regulates the quantity of sugar each mill can sell in the domestic market to prevent oversupply. Each sugar mill is assigned a specific area from which it must purchase all available sugarcane, and farmers in that area must sell to that mill. Because sugarcane loses its sugar content rapidly after being harvested, designating mills based on proximity to growers prevents unnecessary loss. Steep import tariffs are implemented when the government determines that domestic supplies are sufficient to satisfy consumption to protect growers and mills from foreign supplies priced below domestic supplies.

Imports in 2026/27 are forecast down 200,000 tons to 2.4 million, with raw sugar from Brazil accounting for the vast majority. Export quotas are adjusted to ensure adequate supplies for consumers.

The domestic sugar balance sheet indicates that the Indian sugar industry has undergone a significant shift over the last five years. Sugar production has

moderated due to lower sugarcane availability and increasing diversion of sugar for ethanol production. At the same time, domestic consumption has remained relatively stable, while exports have declined sharply due to government restrictions aimed at ensuring domestic availability. Consequently, closing stocks have fallen to more comfortable in 2025-26.

Production Analysis

Declining Sugar Production

- Gross sugar production declined from 389.6 lakh tonnes in 2021-22 to an estimated 309 lakh tonnes in 2025-26.
- Net production decreased from 357.6 lakh tonnes to 280 lakh tonnes, representing a decline of approximately 22%.

Reasons:

- Lower sugarcane availability in key producing states because of weather condition.
- Weather-related challenges affecting cane yields in major sugar production state.
- Diversion of cane and sugar towards ethanol production.

Ethanol Diversion

- Ethanol diversion peaked at 38 lakh tonnes during 2022-23.
- It declined sharply in 2023-24 due to restrictions on sugar diversion.
- Diversion recovered in 2024-25 but remains below earlier highs in 2025-26.

This reflects the government's balancing act between:

- Ensuring sugar availability.

- Achieving ethanol blending targets.

Domestic Consumption

- Average consumption remains around 280 lakh tonnes.
- Demand is relatively inelastic despite fluctuations in production.
- Stable consumption provides predictable demand for sugar producers.

Export Analysis

Exports witnessed the sharpest decline. The key reasons are as follows-

- Government export restrictions.
- Priority to domestic food security.
- Need to maintain adequate domestic stock.
- Lower production levels.

Closing Stock Analysis

- Stocks increased significantly during 2023-24 because exports were nearly halted.
- Stocks subsequently declined as production fell and domestic demand remained steady.
- The projected closing stock of 42.5 lakh tonnes in 2025-26 is at marginal level.

Indian Ethanol Industry Scenario:

After achieving a major milestone under the EBP by reaching an average 20% ethanol blending level in December 2025, five years ahead of schedule, the Ministry of Road Transport and Highways (MoRTH) came out with draft amendments to create ground for increasing the Ethanol Blended Petrol (EBP) to E85 or exclusive ethanol fuel. The draft released on April 27, 2026, indicates a policy direction and the government's push for preparing the vehicle ecosystem for progressively higher ethanol penetration.

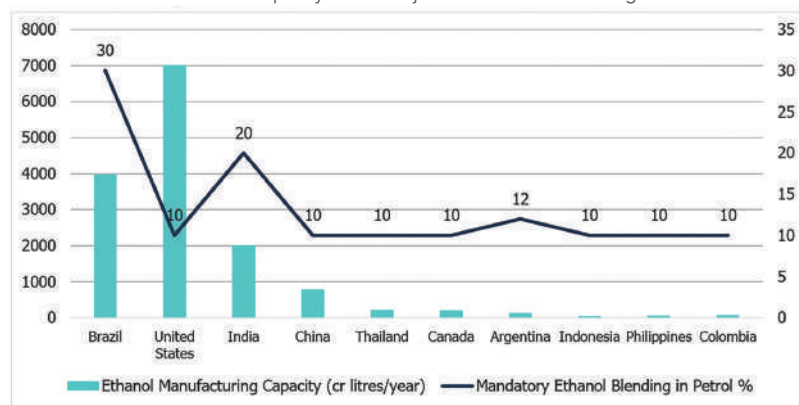
While the policy intent may appear ambitious, it cannot be considered unprecedented. Globally, there has been sustained progress in developing biofuels as a viable and sustainable alternative to fossil fuels, which are characterised by pronounced price volatility, geopolitical risks, and long-standing environmental externalities. Countries have pursued biofuels to enhance energy security and decarbonise

transport systems. Brazil, for instance, has been a pioneer since 1970, systematically building a comprehensive ethanol ecosystem encompassing feedstocks, fuel supply, vehicle technology, and infrastructure, providing a long-standing reference point for large-scale ethanol adoption.

Global Shift Toward Ethanol as a Sustainable Fuel Alternative

Ethanol has emerged as a globally preferred sustainable fuel, offering significant benefits in reducing greenhouse gas emissions, enhancing energy security, promoting agricultural demand, and supporting cleaner, renewable energy transitions across major economies worldwide. The following chart illustrates the ethanol blending mandates and manufacturing capacities of major countries that have implemented EBP as part of their long-term energy transition strategies.

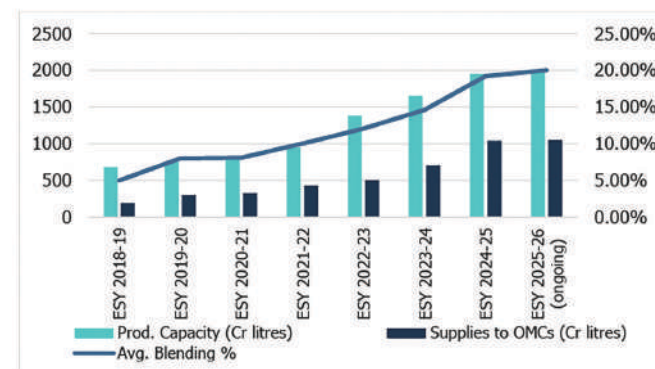
Policy Interventions Driving Rapid Scale-up of Ethanol Capacity

In India, though the Ethanol Blended Petrol (EBP) Programme was formally launched in 2003, progress remained limited—reaching only 1.53% blending by 2014 due to low installed capacity. Over the past decade, the government has implemented several key interventions to accelerate adoption. Since 2014, administered pricing has ensured stable, feedstock-based ethanol rates for producers. The 2016 amendment to the Industries Act streamlined

the movement of interstate ethanol. Financial incentives, including the Interest Subvention Scheme (2018, expanded in 2020), supported capacity expansion. Long-Term Offtake Agreement (LTOA) by oil marketing companies (OMCs) improved investor confidence. At the same time, policy measures such as easing environmental clearances and advancing the E20 target to 2025 have significantly boosted ethanol production capacity, making India the 3rd largest ethanol producer in the world.

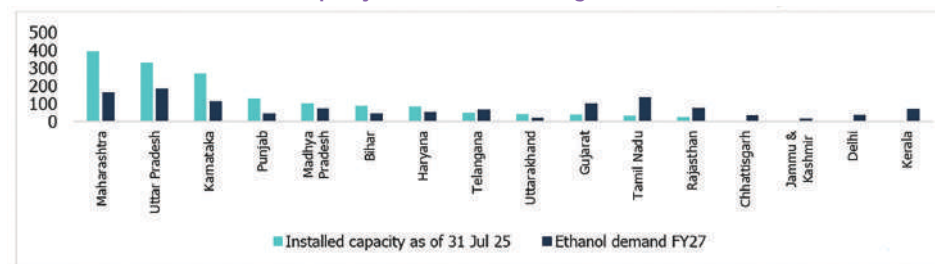
As shown in Exhibit 2 below, the country's ethanol capacity has grown substantially, with production capacity nearly tripling from 680 crore litres in 2018–19 to about 1970 crore litres in 2025–26. Supply to Oil Marketing Companies (OMCs) has expanded even faster, reflecting improved capacity utilisation supported by assured offtake mechanisms.

Consequently, ethanol blending has increased steadily from 5% to around 20%, in line with national targets. The sharp acceleration observed post-2021 underscores the tangible impact of coordinated policy measures, financial incentives, and regulatory support in scaling up the sector.

Ethanol capacity, as seen in Exhibit 3, remains regionally concentrated in India. At the same time, there is a significant surplus in states such as Maharashtra, UP and Karnataka, while several southern and western regions continue to face structural deficits. Despite overall aggregate sufficiency, this imbalance creates localised shortages, leading to logistical inefficiencies, higher supply chain dependency and sustained margin pressures across the ethanol ecosystem. The widening gap between surplus production hubs and deficit consumption centres underscores the

need for balanced capacity addition to improve supply chain efficiency and stabilise realisations.

Ethanol Overcapacity to Persist as Flex-fuel Transition to Remain Gradual

- Capacity Expansion Outpacing Demand:** India's ethanol capacity has scaled to ~2000 crore litres, with an additional 400 crore litres expected to be operational by FY27. The demand under E20 blending is only ~1100 crore litres, with nonfuel demand of around 300-350 crore litres, leaving significant capacity unutilised. This structural

mismatch is reflected in allocation trends, with only ~60% of offered ethanol being absorbed, indicating persistent utilisation pressures across the sector.

- **Regional Imbalance & Logistics Dependence:** Capacity addition is concentrated in select states (UP, Maharashtra, Karnataka), leading to regional surpluses ranging from 277 crore litres surplus in Maharashtra to 77 crore litres deficit in Tamil Nadu. This creates dependence on long-distance transportation and supply redistribution, increasing logistics costs and affecting realisations even when aggregate national capacity is adequate.
- **Demand Growth Hinged on Higher Blends:** At present, ethanol demand is largely capped at ~1100 crore litres under E20 blending, with non-fuel applications contributing only ~300-350 crore litres. Meaningful demand expansion depends on scaling up higher ethanol blends (E85/E100) and Flex Fuel Vehicle (FFV) adoption. In the absence of these demand-side triggers, incremental capacity additions are unlikely to be absorbed in the near term.

- **Infrastructure Constraints :** The ethanol ecosystem remains constrained by a single-grade retail network of ~1.03 lakh outlets, limited storage capacity of ~77.8 crore litres, and reliance on ~300+ centralised depots for blending and distribution. This infrastructure is adequate for E20 rollout but not aligned with multi-blend requirements, thereby restricting the scalability of higher ethanol blends.
- **Shift to Consolidation Phase:** Given the gap between capacity (~2000 crore litres plus upcoming 400 crore litres) and demand (~1100 crore litres for fuel and ~350 crore litres for nonfuel uses), the sector is transitioning into a consolidation phase, with utilisation levels likely to remain in the ~65–75% range for the next three years. Correspondingly, EPC activity has begun to moderate, with industry focus shifting toward brownfield capex, debottlenecking, and operational efficiencies. Allocation dynamics—evidenced by ~700 crore litres of excess supply relative to absorption—are expected to keep margins under pressure in the near to medium term.

Above table shown that the maximum supply shifted to grain as against based on sugar cane & now enough quantity is available for requirement of Ethanol.

In view of proposed E85 & E100 with flexifuel vehicles, the requirement of ethanol definitely be imposed and further notifying the E22, E25, E27 & E30 by BIS, the demand will further be improved.

Given the existing Ethanol capacity and capacity in the pipeline and availability of feed stock, the country showed more forward on a fast-track roadmap towards higher blending level such as

E 27 or any level technically accepted by vehicle manufacturer.

Higher blending level will further:

- Reduce Crude Oil import
- Will help to move Improve energy security
- Strengthen Rural Income
- Lower Carbon Emission

Following policy measurement will help to move forward:

- Promote flexi fuel vehicle
- Develop Ethanol dispensing infrastructure
- Rationalise Taxation

INDIAN PERSPECTIVE OF SUGAR & ETHANOL INDUSTRY

- **FRP:** Fair and Remunerative Price (FRP) of sugarcane for Sugar Season 2025-26 fixed at ₹ 355/qlt (linked to basix recovery of 10.25%) and for Sugar Season 2026-27 (October - September) at ₹365/qlt for a basic recovery rate of 10.25%, providing a premium of ₹3.56/qlt for each 0.1% increase in recovery over and above 10.25%, & reduction in FRP by ₹3.56/qlt for each 0.1% decrease in recovery.
- **SAP:** State Advised Price (SAP) of UP & UK states of sugarcane for the sugar season 2025-26 has increased by ₹ 30/-Qtls. The SAP of UP & UK is ₹ 400 & ₹ 405.00 per quintal respectively for early variety of sugarcane. In case of general variety, it is lesser by ₹ 10/-qlt.

- **Export:** Government of India has prohibited sugar exports with effect from 13th May, 2026 in view of lower sugar stock.
- **Duty Structure:** In line with Excise Duty exemption on E20, to encourage the Ethanol blending Program exemption extended to E22, E25, E27 & E30.
- **MSP:** Minimum Selling Price (MSP) of sugar was first fixed at ₹ 29 per kg in June 2018 and later increased to ₹ 31 per kg in February 2019. MSP is the ex-factory price (excluding GST and transportation charges) below which no mill can sale sugar in India. However, the prevailing market price of sugar is much above the MSP.

Sugarcane Production and Pricing Policy:

The Government of India (GOI) supports research, development, training of farmers and transfer of new varieties and improved production technologies to growers in its endeavour to raise cane yields and sugar recovery rates. Following Cane Development activities which improve the productivity, yield & Sugar Recovery Percentage of Sugarcane, are undertaken:

- Varietal Replacement with proven high recovery varieties.
- Ratoon management.

- Development of Agri Research Centres.
- Integrated Pest Management Programme.
- Soil testing facilities.
- Encouraging use of Bio-fertiliser & Bio-pesticides.
- Training facilities to the Farmers.
- Introduction of Latest methods of farming and use of various mechanical equipments for cultivation.
- Spraying of fertilizer etc.

The Indian Council of Agricultural Research (ICAR) conducts sugarcane research and development at the national level. State agricultural universities, regional research institutions, and state agricultural extension agencies support these efforts at the regional and state levels. The central and state governments also support sugarcane growers by ensuring finances and input supplies at affordable prices. To increase the area of cultivation and production in India, a centrally sponsored scheme called the Sustainable Development Fund of Sugarcane Based Cropping System Area under the Macro Management Mode of Agriculture is being implemented in various sugarcane growing states.

The GOI establishes a Fair and Remunerative Price system (FRP) for sugarcane on the basis of recommendations given by the Commission for Agricultural Costs and Prices (CACP) and after consulting state governments and associations of the sugar industry and cane growers.

Following factors are considered for fixation of FRP:

- Cost of Production of Sugarcane.
- Recovery of Sugar from Sugar cane
- Inter Crop Price parity.
- Price of Sugar Sold.
- Reasonable margins to Farmers.
- Realisation of By Product.
- Return to the growers from alternative crops and the general trend of prices of agricultural commodities;

Citing differences in cost of Production, productivity levels & also as a result of pressure from Farmer's Group, some states declare state specific sugarcane prices called State Advised Prices (SAP), usually higher than FRP.

FRP of sugarcane is fixed to ensure a guaranteed price to sugarcane growers. This would encourage farmers to cultivate sugarcane and would facilitate continued operation of sugar factories and thus would encourage domestic manufacturing of sugar. The FRP is paid by sugar factories to the sugarcane growers against supply of sugarcane. About 5 crore people, i.e., sugarcane farmers and their families, will be benefited by this proposal. Thousands of farm labours are associated with the cane growers and thus payment of FRP to the growers directly benefits them. Secondly, there are about five lakh workers employed in the sugar factories and ancillary activities and their livelihood depends on regular supply of sugarcane by the growers. Fixation of FRP of sugarcane facilitates adequate production and thus availability and supply of cane to sugar factories.

Sugar Mills are required to pay the "State Advised Price (SAP)" to sugarcane farmers irrespective of the Market Price of Sugar. Softening Sugar Prices, coupled with apprehensions of large cane crop, discouraged the sugar mills to pay higher cane prices.

Fair and Remunerative Price (FRP) of sugarcane for sugar season 2025-26 (October - September) at ₹355/qtl for a basic recovery rate of 10.25%, providing a premium of ₹3.46/qtl for each 0.1% increase in recovery over and above 10.25%, & reduction in FRP by ₹3.46/qtl for every 0.1% decrease in recovery.
2. Fair and Remunerative Price (FRP) of sugarcane for Sugar Season 2026-27 (October-September) at ₹365/qtl for a basic recovery rate of 10.25%, providing a premium of ₹3.56/qtl for each 0.1% increase in recovery over and above 10.25%, & reduction in FRP by ₹3.56/qtl for each 0.1% decrease in recovery.

OPPORTUNITIES & THREATS FOR SUGAR INDUSTRY

Opportunities:

Ethanol Blending Program (EBP): India is aggressively advancing its ethanol blending mandates. Diverting excess sugarcane and B-heavy molasses to produce ethanol ensures stable, government-assured cash flows, controlling from volatile global sugar prices etc.

Value-Added Byproducts: Mills are boosting profitability by monetizing byproducts. Bagasse (sugarcane residue) is used for co-generation of green power to sell to the state grid, while press mud is converted into organic bio-compost, boiler ash converted in Potash granules & various speciality product.

Global Market Expansion: As the world's second-largest producer, India can strategically tap into the global raw and white sugar markets during global supply deficits to bolster export revenues.

Technological Advancements: Adopting modern farming techniques, drip irrigation, and high-yielding cane varieties can significantly increase low per-hectare yields and sugar recovery rates.

Threats:

Climatic & Water Risks: Sugarcane is an intensely water-heavy crop. Cultivating it heavily in monsoon-dependent and drought-prone states like Maharashtra and Karnataka threatens long-term environmental sustainability and crop yield stability.

Unpredictable Government Interventions: The government tightly regulates the industry through stock limits, export duties, and minimum pricing (Fair and Remunerative Price - FRP). Balancing consumer inflation control with mill profitability often leads to financial strain for the mills.

Volatile Production Cycles: The industry faces a cyclical "sugar cycle." Surges in sugarcane production lead to crashing market prices and piling stocks, while shortages result in soaring raw material costs and factory sickness.

Competition from Substitutes & Gur: Sugarcane frequently competes with alternative, more lucrative crops like cotton and oilseeds. Furthermore, large-scale diversion of cane toward unorganized gur (jaggery) and khandsari production causes supply disruptions for organized sugar mills.

D. RISKS AND CONCERNS

Sugar industry being agro based is vulnerable to commodity cycles and is hence, fraught with several risks. Given below is a discussion on the risks as perceived by the management. The list is not exhaustive and meant for information purpose only for Investors who are requested to rely on their own judgement while assessing the risks associated with the Sugar Industry and your Company.

a) **Raw material risk** - Sugarcane is the principal raw material used for sugar production. Its availability, quality, growth and cost are affecting factors. These are in turn impacted by uncontrollable factors such as: -

- the area under sugarcane cultivation;
- availability of water;
- Adverse weather conditions and crop disease;
- Availability of better and higher yielding seeds;
- Shifting of farmers' preference to other crops;
- Diversion of sugarcane to other industries like Gur, khandsari etc.;
- Adequacy of harvesting and seasonal unskilled labour;
- Un-remunerative cane procurement price;
- High Local and State level taxes.
- Short crop cycle.
- Fragmented land holding – low yields at farm level.
- Mounting cane arrears.
- Decrease in raw material like red rot etc.

Risk mitigation:

This risk can be mitigated by steps taken by the company through its Cane Development Programme which has yielded results in terms of high yields and recoveries including of varietal replacement and technology adoption. Government programme of Improved Infrastructure for roads and communication; Provision of better quality and higher yielding seeds as well as fertilizers and pesticides; Prompt clearance

of the cane dues of farmers and steps to improve their goodwill by adoption of social development measures such as establishing schools and dispensaries in the command areas etc.; Diversifying into multiple locations etc.

b) Regulatory Risks

i. Environmental Risks

The Industry and Company is subject to environmental regulations and may be exposed to liability as a result of our handling of hazardous materials and potential costs for environmental compliance.

ii. Government policy related Risks

The Industry is regulated and your Company operates in a regulated environment. Central and State Government policies and factors such as:-

- State Advised Price (SAP) and Fair and Remunerative Price (FRP) for sugarcane;
- Control on sale of Molasses; affect the agricultural sector and related industries and in turn our operations and profitability.
- Price of sugar & quantity of sugar selling being decided by the government.

Risk mitigation

The regulatory risks listed above are Government policy driven and beyond Company's control and cannot be alleviated unless the industry is completely decontrolled. Every effort is made to conform to regulatory requirements while judicial recourse is made when warranted. Various representations through the body of the industry like ISMA, UPSMA, and UPDA submitted to the government to come out with the solutions regarding above risks.

All measures taken by the company for zero ground water extraction in sugar plant & zero liquid discharge in distillery.

- c) **Sugar Price Risk-** Sugar prices in the Domestic and International markets depend primarily on the supply and demand situation. Global prices influence and affect the domestic prices directly and sale of Molasses controlled by the respective States. Fluctuations in demand and supply arise on account of the changes in the availability and price of sugarcane, variances in the production capacities of our competitors, availability of substitutes for the sugar products and international demand and supply position.

Risk mitigation

Your Company is unable to mitigate this risk since one does not have any control on the market forces

and the regulatory prices. The wholesale price of sugar has a significant impact on our profits. Like other agricultural commodities, sugar is subject to price fluctuations resulting from weather, natural disasters, domestic and foreign trade policies, shifts in supply and demand and other factors beyond our control. Additionally, 15% to 30% of the total Global sugar production is traded on commodity exchanges which are speculative in nature and can adversely affect the global sugar prices and in turn the operations of your Company.

However, your Company is trying to reduce the impact of this risk by foraying into newer markets, balancing between sugar and ethanol etc, more value addition by concentrating on downstream projects, increasing the quality etc.

Branded and Speciality Sugar

Uttam Sugar Mills Limited produces one of the finest quality sugars in India. The Sugar that we are currently packing is from our sugar plant situated at Libberheri & Khaikheri plant. The quality/purity of sugar is one of the best in the country as we are packing the quality of sugar accepted by European Union Standard. From last fifteen year onwards, your company has entered into a very speciality product of Sugar in the aforesaid plant, this speciality product includes Bura, Brown Sugar, Caster, Sachets (Both in institutional and retail trade), icing sugar, superfine, pharma sugar, cube sugar, invert syrup etc and sugar in the different packaging i.e. 80 gm /500gm/1Kg /2 kg/ 5Kg / 10Kg.

Our packaged sugar is already selling in J&K, Himachal Pradesh, Punjab, Haryana, Delhi, Uttarakhand, Uttar Pradesh, Gujarat, Chandigarh, Rajasthan, Bihar, North East states and Madhya Pradesh through our distributors in the respective areas. We have already covered Modern Retails like Blinkit, Amazon, Flipkart, Zepto, Milk Basket, Leeford, Lots, Mother Dairy, More, Bikanerwala, IRCTC, CCD, Rsana, Dabur, Patanjali, Walmart, Swiggy, DMART, etc.

Uttam Sugar is a very quality centric company and the same will be reflected in our products to come. Our future plans are very ambitious and we want to push Packaged Sugar in Market very aggressively. We would like to inform you that very soon we will be introducing other products along with our existing products.

- d) **Cyclical Risk** - The industry is dependent on monsoons for both production and price realisation. Moreover, switching to other crops by cane growers on account of better returns affect the industry.

Risk mitigation

Your Company is unable to mitigate this risk since one does not have any control on the cyclical nature of the industry. However, Governmental initiatives to improve the irrigation by introducing various schemes as well as improvement in the distribution system by augmentation of the Canal Irrigation and tapping of the available surpluses of water are expected to mitigate this risk significantly.

- e) **Finance Risk-** The Industry is dependent on the availability of timely working capital at competitive interest rates and Long-Term Finance for capacity enhancements / economic size of mills as well as for the manufacture of by-products.

Risk mitigation

Your Company is mostly come out with the financial constraints.

E. INTERNAL CONTROL SYSTEMS AND THEIR ADEQUACY

Broadly, the areas of operation have been classified as Procurement, Manufacture, Marketing and Finance, in the functioning of which, various checks and control systems have been incorporated as Standard Operating Procedures. Even though they are considered adequate to reasonable safeguard its interests, a continuous review is undertaken for further improvement since the management gives lot of emphasis on continuous up gradation of business processes and adherence to the designed system and processes.

Moreover, there is an adequate and effective internal audit system in place in your Company that employs periodic checks on the various systems and on-going process. The Audit Committee of the Board of Directors of your Company comprising of reputed professionals, regularly reviews the effectiveness of internal control system and suggests changes wherever necessary, to ensure due and proper compliance with applicable laws, accounting standards and regulatory guidelines presently in vogue.

Opinion

We have audited the accompanying Standalone Financial Statements of **UTTAM SUGAR MILLS LIMITED** ("the Company"), which comprise the Standalone Balance Sheet as at March 31, 2026, the Standalone statement of Profit and Loss and the Standalone statement of Changes in Equity and the standalone statement of Cash Flows for the year ended on that date and notes to financial statement including a summary of the material accounting policies and other explanatory information (hereinafter referred to as "the Standalone Financial Statements").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid Standalone Financial Statements give the information required by the Companies Act, 2013 as amended ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under section 133 of the Act read with the Companies (Indian Accounting Standards) Rules 2015, as amended, thereof ("Ind AS ") and other accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2026, the standalone profit, changes in equity and its cash flows for the year ended on that date.

Basis for Opinion

Keeping in view that no demand has ever been raised by the State Government and the application for waiver of outstanding loan and interest thereon has been filed with the appropriate authority, company has pending the final outcome of the matter has not accounted for interest on the said loan after 31.03.2024 which aggregates to ₹52.52 lakh up to the year ended 31st March, 2026 (₹ 26.26 Lakh for previous year ended 31st March, 2025).

Our opinion is not modified in respect of this matter.

Key Audit Matters

Notes on Standalone Financial Statements for the year ended 31st March 2026

Note No. 1 : Corporate Information

Uttam Sugar Mills Ltd. ("USML" or the Company) is a public limited Company incorporated and domiciled in India. The registered office of the Company is situated at Village Libberheri, Tehsil Roorkee, Distt. Haridwar (Uttarakhand).

The Company's shares are listed on the BSE Limited and National Stock Exchange of India Ltd.

The Company is engaged in the manufacture of Sugar, Industrial Alcohol and Generation of Power. The Standalone Financial Statements of the Company are for the year ended 31st March, 2026 and are prepared in Indian Rupees being the functional currency. The values in Rupees are rounded off to nearest rupee in lakhs up to two decimals, except otherwise indicated.

The Standalone Financial Statements for the year ended 31st March, 2026 was approved by the Board of Directors of the Company on 15th May, 2026 and is subject to the adoption by the shareholders in the Annual General Meeting.

Note No. 2 : Material Accounting Policies

2.1 Statement of compliance with Ind AS

The Standalone Financial Statements of the Company have been prepared to comply with the Indian Accounting Standards ('Ind AS') notified under Companies (Indian Accounting Standards) Rules, 2015 (as amended from time to time) read with Section 133 of the Companies Act, 2013 and other relevant provision and presentation requirement of Division II of Schedule III of the Companies Act as applicable.

The company has assessed the materiality of the accounting policy information which involves exercising judgements and considering both qualitative and quantitative factors by taking into account not only the size and nature of the item or condition but also the characteristics of the transactions, events or conditions that could make the information more likely to impact the decisions of the users of the financial statements.

Entity's conclusion that an accounting policy is immaterial does not affect the disclosures requirements set out in the accounting standards.

All the Ind AS issued and notified by the Ministry of Corporate Affairs under the Companies (India Accounting Standards) Rules 2015 (As amended) till the Standalone Financial Statements are approved for issue by the Board of Directors has been considered in preparing these financial statements.

2.2 Basis of preparation

These Standalone Financial Statements have been prepared in accordance with Ind AS under the historical cost basis except for the following.

- Certain financial assets and financial liabilities— measured at fair value and
- Defined benefits plan— plan assets measured at fair value.
- Biological assets that are measured at fair value, assets held for sale which is measured at lower of cost and fair value less cost to sell.

Accounting Policies have been consistently applied except where a newly issued IND AS is initially accepted or a revision to an existing IND AS requiring change in the accounting policies hitherto in use.

2.3 The Company presents assets and liabilities in the balance sheet based on current/non-current classification.

An asset is treated as current when it is:

- Expected to be realized or intended to be sold or consumed in normal operating cycle,
 - Held primarily for the purpose of trading,
 - Expected to be realized within twelve months after the reporting period,
 - Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period, or
 - Carrying current portion of non-current financial assets.
- All other assets are classified as non-current.

Notes on Standalone Financial Statements for the year ended 31st March 2026

A liability is current when:

- It is expected to be settled in normal operating cycle,
 - It is held primarily for the purpose of trading,
 - It is due to be settled within twelve months after the reporting period,
 - the Company does not have a right at the end of the reporting period to defer settlement of the liability for at least twelve months after the reporting period,
 - The Company's right to defer settlement of a liability for at least twelve months after the reporting period must exist at the end of the reporting period. Classification of a liability is unaffected by the likelihood that the Company will exercise its right to defer settlement,
 - Where the right to defer settlement is subject to compliance with covenants, such right exists only if the Company complies with those covenants on or before the end of the reporting period where testing of such covenants is required on or before the end of the reporting period,
 - It includes current portion of non-current financial liabilities.
- All other liabilities are classified as non-current.

2.4 Revenue recognition

Revenue from sale of product is recognized at the point in time when control of the goods is transferred to the customer, generally on delivery of the product.

At contract inception, the Company assess the goods promised in a contract with a customer and identify as a performance obligation each promise to transfer to the customer. Revenue from contracts with customers is recognized when control of goods or services are transferred to customers and the Company retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold.

Revenue is measured at the fair value of the consideration received or receivables, net of returns and allowances, trade discounts and volume rebates. Revenue is recognized to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured, regardless of when the payment is being made.

Revenue is measured at the fair value of the consideration received or receivable, taking into account contractually defined terms of payment and excluding taxes or duties collected on behalf of the Government. The Company bases its estimates on historical results, taking into consideration the type of customer, the type of transaction and the specific of each arrangement.

Revenue from sale of power is recognized when the units generated are transmitted to the pooling station, in accordance with the terms and conditions of the power purchase agreement entered into by the Company with the purchasing parties.

Income from sale of REC is recognized on delivery of REC to the customers 'account.

Export incentives are accounted for in the year of exports based on eligibility and when there is no significant uncertainty in receiving the same.

Interest income from a financial asset is recognized when it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the "effective interest rate" that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's gross carrying amount.

Insurance claims are accounted for on the basis of claims admitted / expected to be admitted and to the extent that there is no uncertainty in receiving the claims.

All other incomes are accounted for on accrual basis.

2.5 Expenses

All expenses are accounted for on accrual basis.

2.6 Property, plant and equipment and Capital work in progress (CWIP)

All property, plant and equipment are measured at cost less accumulated depreciation and accumulated impairment losses, if any. Free hold land is not depreciated. The cost of an asset includes the purchase cost of

Notes on Standalone Financial Statements for the year ended 31st March 2026

materials, including import duties and non-refundable/ creditable taxes and any directly attributable cost of bringing an asset to the location and condition of its intended use and costs of dismantling and removing the item and restoring the site on which it is located, interest on borrowing used to finance the construction of qualifying assets are capitalized as part of the cost of the asset until such time that the asset is ready for its intended use.

When significant parts of property, plant and equipment are required to be replaced at intervals, the Company depreciates them separately based on their specific useful lives. Likewise, when a major refurbishment is performed, its cost is recognized in the carrying amount of the plant and equipment as a replacement if the recognition criteria are satisfied. All other repairs and maintenance costs are recognized in statement of profit and loss as incurred.

Items of spare parts, stand-by equipment and servicing equipment which meet the definition of property, plant and equipment are capitalized. Other spare parts are carried as inventory and recognized in the statement of profit and loss on consumption. When parts of an item of PPE have different useful lives, they are accounted for as separate component.

Directly attributable expenditure (including finance cost relating to borrowed funds for construction or acquisition of fixed assets) incurred on projects under implementation are treated as pre-operative expenses pending allocation to the assets and are shown under CWIP, CWIP is stated at the amount expended up to balance sheet date on assets or property, plant and equipment that are not yet ready for their intended use.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment.

The cost and related accumulated depreciation are eliminated from the Standalone Financial Statements upon disposal/ sale or retirement of the asset and the resultant gains or losses (difference between the sale proceeds and the carrying amount of the assets) are recognized in the Statement of profit and Loss.

2.7 Depreciation methods, estimated useful lives and residual value

- Depreciation on property, plant and equipment provided on Straight Line basis so as to charge the cost of the assets or the amount substituted for costs in case of revalued assets less its residual value over the useful life of the respective asset as prescribed under part C of Schedule II to the Companies Act, 2013. Residual value has been considered as 5% of the cost of the respective assets.
- Leasehold Building Developments are amortized at lower of period of lease or ten years.
- Intangible Assets are amortized over a period of economic benefits not exceeding ten years.
- Depreciation/amortization on assets added, sold or discarded during the year is provided on pro – rata basis.

2.8 Intangible assets (Computer software)

Intangible assets are stated at cost of acquisition net of recoverable taxes less accumulated amortization/ depletion and impairment loss, if any. The cost comprises purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for the intended use. An intangible asset is derecognized on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from de-recognition of an intangible asset are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognized in the Statement of profit and loss when the asset is derecognized.

2.9 Inventories

Inventories (other than By-products) are valued at lower of cost or net realizable value.

Inventories of Renewable Energy Certificates (REC) are valued at lower of cost or net realizable value.

Inventories on stock in trade are valued at lower of cost or net realizable value.

Cost of inventories has been determined on current cost.

Chemicals, packing material and other store & spares at purchase cost including incidental expenses on -weighted average basis.

Cost of finished goods and Work in Progress has been worked out on absorption cost basis.

By- products and residuals are valued at net realizable value except in case of B Heavy Molasses which is valued by considering the realizable value of C Heavy Molasses plus sugar sacrificed for producing B Heavy Molasses.

Net realizable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and estimated costs necessary to make the sale.

Assessment of net realizable value is made at each subsequent reporting date. When the circumstances that previously caused inventories to be written down below cost no longer exist or when there is clear evidence of an increase in net realizable value because of changed economic circumstances, the amount so written-down is adjusted in terms of policy as stated above.

2.10 Government Grants

Government grants are recognized at fair value when there is reasonable assurance that the grant would be received and the Company would comply with all the conditions attached with them.

Government grants related to property, plant and equipment are treated as deferred revenue (included under non-current liabilities with current portion considered under current liabilities) and are recognized and credited in the statement of profit and loss on systematic and rational basis and included under other income.

Government grants related to revenue nature are recognized on a systematic basis in the Statement of profit and Loss over the periods necessary to match them with the related costs which they are intended to compensate and are adjusted with the related expenditure.

(If not related to a specific expenditure, it is taken as income and presented under: other Income)

2.11 Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of assets are capitalized as part of the cost of such assets. A qualifying asset is one that necessarily takes substantial period of time to get ready for its intended use. Interest income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalization. All other borrowing costs are charged to the profit and loss statement in the period in which they are incurred.

Preference Shares, which are mandatorily redeemable on a specific date are classified as liabilities. The dividend on these preference shares is recognized as finance cost in the Statement of Profit and Loss.

2.12 Leases

The Company assesses at contract inception whether a contract is, or contains, a lease. That is, if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

As a lessee the Company applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Company recognizes lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

Right-of-use assets The Company recognizes right-of-use assets at the commencement date of the lease (i.e., the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognized, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received.

Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease term and the estimated useful lives of the assets. If ownership of the leased asset transfers to the Company at the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset. The right-of-use assets are also subject to impairment.

The right-of-use assets are disclosed in Property, Plant and Equipment (see Note 3).

Lease Liabilities At the commencement date of the lease, the Company recognizes lease liabilities measured at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees.

In calculating the present value of lease payments, the Company uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in the lease payments (e.g., changes to future payments resulting from a change in an index or rate used to determine such lease payments) or a change in

the assessment of an option to purchase the underlying asset. Lease liabilities are included in Other financial liabilities.

Short-term lease and lease of low-value assets The Company applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (i.e., those leases that have a lease term of twelve months or less from the commencement date and do not contain a purchase option). It also applies the lease of low-value assets recognition exemption to leases of offices, godowns, equipment, etc. that are of low value. Lease payments on short-term leases and leases of low-value assets are recognized as expense on a straight-line basis over the lease term.

2.13 Provisions, contingent liabilities and contingent assets.

Provisions involving substantial degree of estimation in measurement are recognized when there is a present obligation as a result of past events and it is probable that there will be an outflow of resources.

If the effect of the time value of money is material, provisions are determined by discounting the expected future cash flows at current pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability when discounting is used, the increase in the passage of time is recognized as finance costs.

A contingent liability is a possible obligation that arises from past events whose existence will be confirmed by the occurrence or non-occurrence of one or more uncertain future events beyond the control of the Company or a present obligation that is not recognized because it is not probable that an out flow of resources will be required to settle the obligation. A contingent liability also arises in extremely rare cases where there is liability that can't be recognized because it can't be measured reliably.

A contingent liability is not recognized in the financial statements, but discloses its existence in the Financial Statement.

When the realization of income is virtually certain, then the related asset is no longer a contingent asset, and is recognized as an asset.

Provisions, contingent liabilities and contingent assets are reviewed at each balance sheet date.

2.14 Dividend payable

Final dividend on shares is recorded as a liability on the date of approval by the shareholders and interim dividend are recorded as a liability on the date of declaration by the Company's Board of Directors. A corresponding amount is recognized directly in equity.

2.15 Foreign currency transactions

Transactions in foreign currency are recorded at the exchange rate prevailing on the date of transaction. Monetary items denominated in foreign currencies at the year ended translated at the year ended rates which is likely to be realized from, or required to disburse at the balance sheet date. Exchange differences arising on settlement of monetary items at rates different from those at which they were initially recorded / reported in Standalone Financial Statements are recognized as income or expense in the year in which they arise.

Non-monetary items which are carried at historical cost denominated in a foreign currency are translated using the exchange rate at the date of the initial transaction.

2.16 Employee benefits

- Short-term employee benefits are recognized as an expense at the undiscounted amount in the Statement Profit & Loss Account of the period in which the related service is rendered.
- Long-term employee benefits are recognized as an expense in the Statement Profit & Loss Account for the year in which the employee has rendered services.

Defined Benefit Plans

The Company's liabilities on account of gratuity and earned leaves on retirement of employees are determined at the end of each financial year on the basis of actuarial valuation certificates obtained from registered actuary in accordance with the measurement procedure as per Indian Accounting Standard (INDAS)-19- 'Employee Benefits'.

i. Compensated absences

Accumulated leave, which is expected to be utilized within next 12 months, is treated as short term employee benefit and this is shown under current provisions in the Balance Sheet. The Company treats accumulated leave expected to be carried forward beyond twelve months, as long-term employee benefits and shown under long term provisions in the Balance sheet.

ii. Gratuity

The Company provides for retirement benefits in the form of gratuity. The Company's liability towards this benefit is determined on the basis of actuarial valuation using projected unit credit method at the date of Balance sheet. Actuarial gain and Losses in respect of such benefits are recognized in Other Comprehensive Income.

2.17 Financial instruments

A Financial instrument is any contract that gives rise to financial assets of one entity and a financial liability or equity instrument of another party.

A. Financial Assets

a. Initial recognition

The Company classifies financial instruments, or their component parts, on initial recognition as a financial asset, a financial liability or an equity instrument in accordance with the substance of the contractual arrangement. Financial instruments are recognized when the Company becomes a party to the contractual provisions of the instrument. Financial instruments are recognized initially at fair value plus transactions costs that are directly attributable to the acquisition or issue of the financial instrument, except for financial assets at fair value through statement of profit and loss, which are initially measured at fair value, excluding transaction costs (which is recognized in statement of profit and loss).

b. Subsequent measurement

i) Financial assets carried at amortized cost (AC)

A financial asset is subsequently measured at amortized cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

ii) Financial assets at fair value through other comprehensive income (FVTOCI)

A financial asset is subsequently measured at fair value through other comprehensive income if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

iii) Financial assets at fair value through statement of profit and loss (FVTPL)

Equity instruments

All equity investments in scope of Ind AS 109 are measured at fair value either as at FVTOCI or FVTPL. The Company makes such election on instrument-by-instrument basis. For equity instruments measured as at FVTOCI, all fair value changes on the instrument, excluding dividends, are recognized in the OCI. Equity instruments included within the FVTPL category are measured at fair value with all changes recognized in the Statement of Profit & Loss account.

c. De-recognition

A Financial Assets (or where applicable, part of financial assets) is primarily derecognized when:

- The contractual right to receive cash flows from the assets have expired or
- The Company has transferred its right to receive cash flow from the financial assets and subsequently all the risks and rewards of ownership of the assets to third party.

d. Reclassification of financial assets

Company determines the classification of financial assets and liabilities on initial recognition. After initial recognition, no reclassification is made for financial assets which are equity instruments and financial liabilities.

e. Impairment of financial assets

The Company recognized loss allowance using the expected credit loss (ECL) model for the financial assets which are not fair valued through Statement of Profit and loss. Loss allowance for trade receivable with no significant financing component is measured at an amount equal to life time ECL.

For all other financial assets, expected credit loss are measured at an amount equal to the twelve-month ECL, unless there has been a significant increase in credit risk from initial recognition in which case those are measured at lifetime ECL.

B. Financial liabilities

a. Initial recognition and measurement

All financial liabilities are recognized initially at fair value and in case of loans and borrowings and payables, net of directly attributable cost. The Company's financial liabilities include trade and other payable, loans and borrowing including bank over drafts, financial guarantee contracts and derivative financial instruments. Fees of recurring nature are directly recognized in statement of profit and loss as finance cost.

b. Subsequent measurement:

Financial liabilities are subsequently carried at amortized cost using the effective interest method. For trade and other payables maturing within one year from the balance sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

i) Loans and borrowings

After initial recognition, interest bearing loans and borrowings are subsequently measured at amortized cost using the effective interest rate (EIR) method. Gains and losses are recognized in statement of profit and loss when liabilities are de-recognized. Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortization is included as finance cost in the statement of profit and loss.

ii) Compound financial instruments

At the issue date the fair value of the liability component of a compound instrument is estimated using the market interest rate for a similar non-convertible instrument. This amount is recorded as a liability at amortized cost using the effective interest method until extinguished upon conversion or at the instrument's redemption date. The equity component is determined as the difference of the amount of the liability component from the fair value of the instrument. This is recognized in equity, net of income tax effects, and is not subsequently re-measured.

c. De-recognition of financial instruments

A financial liability is derecognized where the obligation under the liability is discharged or cancelled or expires where an existing financial liability is replaced by another from the same tender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the de-recognition of the original liability and the recognition of new liability. The difference in the respective carrying amounts is recognized in the statement of Profit and Loss.

d. Offsetting of financial instruments

Financial assets and financial liabilities including derivative instruments are offset and the net amount is reported in the Balance sheet, if there is a currently enforceable legal right to offset the recognized amounts and there is an intention to settle on a net basis or to realize the assets and settle the liabilities simultaneously.

e. Fair value measurement

Fair value is a market-based measurement, not an entity-specific measurement. Under Ind AS, fair valuation of financial instruments is guided by Ind AS 113 "Fair Value Measurement" (Ind AS – 113).

For some assets and liabilities, observable market transactions or market information might be available. For other assets and liabilities, observable market transactions and market information might not be available. However, the objective of a fair value measurement in both cases is the same to estimate the price at which an orderly transaction to sell the asset or to transfer the liability would take place between market participants at the measurement date under current market conditions (i.e. an exit price at the measurement date from the perspective of a market participant that holds the asset or owes the liability).

Three widely used valuation techniques specified in the said Ind AS are the market approach, the cost approach and the income approach which have been dealt with separately in the said Ind AS.

Each of the valuation techniques stated as above proceeds on different fundamental assumptions, which have greater or lesser relevance, and at times there is no relevance of a particular methodology to a given situation. Thus, the methods to be adopted for a particular purpose must be judiciously chosen. The application of any particular method of valuation depends on the Company being evaluated, the nature of industry in which it operates, the Company's intrinsic strengths and the purpose for which the valuation is made.

In determining the fair value of financial instruments, the Company uses a variety of methods and assumptions that are based on market conditions and risks existing at each balance sheet date.

The Company uses the following hierarchy for determining and disclosing the fair value of financial instruments by valuation technique:

Level 1 : Quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2 : Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 : Inputs for the assets or liabilities that are not based on observable market data (unobservable inputs)

f) Share capital

An equity instrument is a contract that evidences residual interest in the assets of the Company after deducting all of its liabilities. Incremental costs directly attributable to the issuance of new equity shares are recognized as a deduction from equity, net of any tax effects.

2.18 Impairment Non-financial assets

The carrying amount of any property, plant and equipment and intangible assets with finite lives are reviewed at each balance sheet date, if there is any indication of impairment based on internal /external factor. An asset is impaired when the carrying amount of the asset exceeds the recoverable amount. Recoverable amount is higher of an asset's or cash generating unit's net selling price and its value in use. Recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or group of assets.

An impairment loss is charged to the Statement of Profit and loss in the year in which an asset is identified as impaired. An impairment loss recognized in prior accounting periods is reversed if there has been change in the estimate of the recoverable amount. At each balance sheet date, the Company assesses whether there is any indication that any property, plant and equipment and intangible assets with finite lives may be impaired. If any such impairment exists, the recoverable amount of an asset is estimated to determine the extent of impairment. If at the balance sheet date there is an indication that a previously assessed impairment loss no longer exists, the recoverable amount is reassessed and the impairment loss previously recognized is reversed such that the asset is recognized at its recoverable amount but not exceeding written down value which would have been reported if the impairment loss had not been recognized.

2.19 Taxes

Income tax expense comprises current tax and deferred tax and is recognized in the Statement of Profit and Loss except to the extent it relates to items directly recognized in Equity or in Other Comprehensive Income (OCI).

Current tax

Provision for current tax is made with reference to taxable income computed for the accounting period for which the Standalone Financial Statements are prepared by applying the tax rates and laws that are enacted or substantively enacted at the balance sheet date. The tax is recognized in statement of profit and loss, except to the extent that it related to items recognized in the OCI or in other equity. In this case, the tax is also recognized in other comprehensive income and other equity.

The Company offsets current tax assets and current tax liabilities, where it has a legally enforceable right to set off the recognized amounts and where it intends either to settle on a net basis or to realize the assets and settle the liabilities simultaneously.

Deferred tax

Deferred tax is recognized using the balance sheet approach. Deferred tax assets and liabilities are recognized for deductible and taxable temporary differences arising between the tax base of assets and liabilities and their carrying amount in financial statements, except when the deferred tax arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and affects neither accounting nor taxable profits or loss at the time of the transaction.

Deferred tax assets are recognized for deductible temporary differences, the carry forward of and any unused tax losses to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carry forward of unused tax losses can be utilized.

The carrying amount of deferred tax assets is reviewed at each balance sheet date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax assets to be recovered.

Unrecognized deferred tax assets are re-assessed at each balance sheet date and are recognized to the extent that it has become probable that future taxable profits will allow the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the year when the asset is realized or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the balance sheet date.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off deferred tax assets against deferred tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority.

2.20 Earnings per Share

The Company presents basic and diluted earnings per share ("EPS") data for its equity shares. Basic EPS is calculated by dividing the profit/loss before other comprehensive income/loss for the year attributable to equity shareholders of the Company by the weighted average number of equity shares outstanding during the period. Diluted EPS is determined by adjusting the profit/loss before other comprehensive income/loss for the year attributable to equity shareholders and the weighted average number of equity shares outstanding for the effects of all dilutive potential equity shares.

2.21 Non-current assets (or disposal groups) held for sale and discontinued operations

a) Non-current assets (or disposal groups) are classified as held for sale if their carrying amount would be recovered principally through a sale/distribution rather than through continuing use and a sale/distribution is considered highly probable.

Actions required to complete the sale/distribution should indicate that it is unlikely that significant changes to the sale/ distribution would be made or that the decision to sell/distribute would be withdrawn. Management must be committed to sale/distribution expected within one year from the date of classification.

b) Immediately before the initial classification of the assets (and disposal groups) as held for sale, the carrying amount of the assets (or all the assets and liabilities in the disposal groups) are measured in accordance with their applicable accounting policy.

Non-current assets (or disposal groups) held for sale/for distribution to owners are subsequently measured at the lower of their carrying amount and fair value less costs to sell, except for assets such as deferred tax assets, assets arising from employee benefits and financial assets which are specifically exempt from this requirement.

c) Non-current assets including those that are part of a disposal group (PPE and Intangible assets) once classified as held for sale/ distribution to owners are neither depreciated nor amortized. Interest and other expenses attributable to the liabilities of a disposal group classified as held for sale continue to be recognized.

d) Non-current assets (including assets of a disposal group) classified as held for sale are presented separately from the other assets in the Balance sheet. The liabilities of a disposal group classified as held for sale/ distribution are presented separately from other liabilities in the Balance sheet.

e) A disposal group qualifies as discontinued operation, if it is a component of equity that has either being disposed of or is classified as Held for sale, and that represents a separate major line of business or

geographical area of operations, or is part of a single co-ordinate plan to dispose of a separate major line of business or geographical area of operations or is a subsidiary exclusively with a view to resale.

Discontinued operations are excluded from the results of continuing operations and are presented separately as a single amount as profit or loss after tax from discontinued operations in the Statement of Profit and Loss and comparative information is restated accordingly.

f) All notes to the Standalone Financial Statements mainly include amounts for continuing operations, unless stated otherwise.

2.22 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. Revenue and expenses are identified to segments on the basis of their relationship to the operating activities of the segment. Inter segment revenue are accounted for based on the cost price. Revenue, expenses, assets and liabilities which are not allocable to segments on a reasonable basis, are included under "Unallocated revenue/ expenses/ assets/ liabilities". The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Managing Director who makes strategic decisions.

The accounting policies adopted for segment reporting are in line with the accounting policies adopted for preparing and presenting the Standalone Financial Statements of the Company as a whole.

2.23 Cash and cash equivalents

Cash and cash equivalents in the Balance sheet comprise cash on hand, cheques on hand, balance with banks on current accounts and debit balance of cash credit account if any and short term, highly liquid investments with an original maturity of three months or less and which carry insignificant risk of changes in value.

For the purpose of the Cash Flow Statement, Cash and cash equivalents consist of Cash and cash equivalents, as defined above and net of outstanding book overdrafts as they are considered an integral part of the Company's cash management.

2.24 Cash Flow Statement

Cash flows are reported using the indirect method, whereby profit/loss before tax is adjusted for the effects of transactions of a non-cash nature, any deferrals or accruals of past or future operating cash receipts or payments and item of income or expenses associated with investing or financing flows. The cash flows from operating, investing and financing activities of the Company are segregated.

Note No. : 2A Key accounting judgment, estimates and assumptions

The preparation of the Standalone Financial Statements requires the use of accounting estimates, which, by definition would seldom equal the actual results. Management also needs to exercise judgment and make certain assumptions in applying the Company accounting policies and preparation of Standalone Financial Statements

The use of such estimates, judgments and assumptions affects the reported amounts of revenue, expenses, assets and liabilities including the accompanying disclosures and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in the future periods.

Estimates and judgments are continually evaluated. They are based on historical experience and other factors including expectations of future events that may have a financial impact on the Company and that are believed to be reasonable under the circumstances.

Estimates and assumptions

The Company has based its assumptions and estimates on parameters available when the financial statement was prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising that are beyond the control of the Company. Such changes are reflected in the assumptions when they occur.

The key assumptions concerning the future and other key sources of estimation uncertainty at the balance sheet date that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are described below.

i) **Depreciation and useful lives of property, plant and equipment:** Property, plant and equipment are depreciated over the estimated useful lives of the assets, after taking into account their estimated residual

value. Management reviews the estimated useful lives and residual values of the assets annually in order to determine the amount of depreciation to be recorded during any reporting period. The useful lives and residual values are based on the Company's historical experience with similar assets and take into account anticipated technological changes. The depreciation for future periods is adjusted if there are significant changes from previous estimates.

- ii) **Income Tax:** Management judgment is required for calculation of income tax and deferred tax assets and liabilities. Deferred tax assets are recognized for unused losses (carry forward of prior years' losses) to the extent that it is probable that taxable profit would be available against which the losses could be utilized. The Company reviews at each balance sheet date the carrying amount of deferred tax. The factor used in estimate may differ from actual outcome which may lead to significant adjustment in the amounts in financial statement.
- iii) **Recoverability of trade receivable:** Judgments are required in assessing the recoverability of overdue trade receivables and determining whether a provision against those receivables is required. Factors considered include the credit rating of the counterparty, the amount and timing of anticipated future payments and any possible actions that can be taken to mitigate the risk of non-payment.
- iv) **Provisions for contingencies:** Provisions are recognized in the period when it becomes probable that there will be a future outflow of funds resulting from past operations or events and the amount of cash outflow can be reliably estimated. The timing of recognition and quantification of the liability require the application of judgment to existing facts and circumstances, which can be subject to change. Since the cash outflows can take place many years in the future, the carrying amounts of provisions and liabilities are reviewed regularly and adjusted to take account of changing facts and circumstances.
- v) **Impairment of non-financial assets:** The Company assesses at each reporting date whether there is an indication that an asset may be impaired. If any indication exists, or when annual impairment testing for an asset is required, the Company estimates the asset's recoverable amount. An asset's recoverable amount is the higher of an asset's or CGU's fair value less costs of disposal and its value in use. It is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. Where the carrying amount of an asset or CGU exceeds its recoverable amount, the asset is considered impaired and is written down to its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using pretax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. In determining fair value less costs of disposal, recent market transaction are taken into account, if no such transactions can be identified, an appropriate valuation model is used.
- vi) **Estimation of Defined benefit obligations:** The Company's obligation on account of gratuity and compensated absences is determined based on actuarial valuation.
An actuarial valuation involves making various assumptions that may differ from actual developments in the future. These include the determination of the discount rate, future salary increases and mortality rates. Due to the complexities involved in the valuation and its long-term nature, a defined benefit obligation is highly sensitive to changes in these assumptions. All assumptions are reviewed at each financial year end.
- vii) **Impairment of financial assets:** The impairment provisions for financial assets are based on assumptions about risk of default and expected cash loss rates. The Company uses judgment in making these assumptions and selecting the inputs to the impairment calculation, based on Company's past history, existing market conditions as well as forward looking estimates at the end of each reporting period.
- viii) **Fair value measurement of financial instruments:** When the fair value of the financial assets and liabilities recorded in the balance sheet cannot be measured based on the quoted market price in active markets, their fair value is measured using valuation technique. The input to these models are taken from the observable market where possible, but if this is not feasible, a review of judgment is required in establishing fair values. Changes in assumption relating to this assumption could affect the fair value of financial instrument.
- ix) **Material uncertainty about going concern:** In preparing financial statements, management has made an assessment of Company's ability to continue as a going concern. Standalone Financial Statements are prepared on a going concern basis. The Management is aware, in making its assessment, of material uncertainties related to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

Recent pronouncements

Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time.

In May 2025, MCA notified amendments to Ind AS 21 - The Effects of Changes in Foreign Exchange Rates, applicable w.e.f. April 1, 2025. The Ministry of Corporate Affairs (MCA) notified the Companies (Indian Accounting Standards) Amendment Rules, 2025, which amend Ind AS 21, The Effects of Changes in Foreign Exchange Rates to specify how an entity should assess whether a currency is exchangeable and how it should determine a spot exchange rate when exchangeability is lacking. The amendments also require disclosure of information that enables users of its Standalone Financial Statements to understand how the currency not being exchangeable into the other currency affects, or is expected to affect, the entity's financial performance, financial position and cash flows.

The Company has reviewed the amendment and based on its evaluation has determined that it does not have any impact in its financial statements.

In August 2025, MCA notified the following amendments to:

1. Ind AS 1, Presentation of Financial Statements, applicable w.e.f. April 1, 2025 –
The amendment relates to classification of liabilities as current or non-current and non-current liabilities with covenants. In the context of classifying a liability as current, it removes the requirement of existence of a right to defer settlement for at least 12 months after the reporting date and instead requires that the said right should exist on the reporting date and have substance. The amendment also introduces guidance on classification of liabilities with covenants.
A requirement has been introduced to require disclosure when a liability arising from a loan agreement is classified as non-current and the entity's right to defer settlement is contingent on compliance with future covenants within twelve months.
If there is a breach of a material covenant of a long term loan arrangement on or before the end of the reporting period, resulting in the liability becoming payable on demand as at the reporting date, and the lender agrees—after the reporting period but before the Standalone Financial Statements are approved for issue—not to demand repayment for at least 12 months as a consequence of the breach, this shall be treated as an adjusting event. Accordingly, the entity is not required to classify the liability as current. The amendments are effective for annual reporting periods beginning on or after 1 April 2025 retrospectively in accordance with Ind AS 8.
The Company has no impact of these amendments in its classification criteria of current and non-current liabilities.
2. Ind AS 7, Statement of Cash Flows and Ind AS 107, Financial Instruments: Disclosures, applicable w.e.f. April 1, 2025 –
The amendment in Ind AS 7 requires to inform users of Standalone Financial Statements of the existence of supplier finance arrangements and explain the nature of the arrangements, the carrying amount of liabilities and the range of payment due dates. Ind AS 107 has been amended to add supplier finance arrangements as a factor that may cause concentration of liquidity risk. Since the company does not have any supplier finance arrangement the same is not applicable to the company.

- b. All the Current assets, loans and advances, in the opinion of the Board, have a value on realization which in the ordinary course of business shall at least be equal to the amount at which it is stated in the balance sheet.
- c. The Company has made an investment of the requisite amount for setting up new projects in the State of Uttar Pradesh in accordance with the UP Sugar Industry Promotion Policy, 2004 and has accordingly filed application for eligibility under the above policy. However, the State Government has later on terminated the Policy with effect from June 4, 2007. The Company had filed writ petition before Hon'ble Allahabad high court (Lucknow Bench) for enforcement of the scheme and settlement of incentive claims.
- The writ petitions were allowed vide common Judgment dated 12.02.2019 of Hon'ble Allahabad High court (Lucknow Bench) that the petitioners are entitled for consideration of all the benefits in the form of exemptions/ remission/ reimbursements as per the Sugar Industry Promotion Policy – 2004 and various notifications issued thereunder from time to time for the entire period of the validity of the Policy. As per Hon'ble court, Since the matter has become quite old it will be appropriate that the cases may be examined and benefits may be given within a maximum period of two months from the date of order.
- The State Government has challenged the order of the Hon'ble Allahabad High court (Lucknow Bench) in Supreme Court where their petition has been admitted, and now the matter is pending with Supreme Court. However, The Company have submitted the claim on 4th September 2020 with Cane Commissioner of Uttar Pradesh (Appropriate Authority) for an amount of ₹3847 lakhs as Capital Subsidy and for remission / exemption / reimbursement of taxes, duties and other charges aggregating of ₹5489 lakhs. The claim will be accounted for as and when it will be approved by the appropriate authority.
- d. Investment Promotion and Facilitation Agency of Government of Uttar Pradesh (INVEST U.P.) had issued letter of comfort on 12.01.2020 for grant facilities / relief under Industrial Investment and Employment Promotion policy-2017 (IIEPP-2017) and in accordance to which Company has accounted for and submitted claim of ₹108.75 lakhs on 19.02.2021 with PICUP which includes interest subsidy of ₹92.69 lakhs and ₹16.06 lakhs for GST/VAT refund. The matter is under process with INVEST U.P. for final disposal.
- e. The Company has expanded capacity from 150 KLPD to 250 KLPD at plant situated at Village Barakatpur. Letter of comfort has been issued on 29.10.2024 under Industrial Investment and Employment Promotion policy-2022 (IIEPP-2022). Application of claim for capital subsidy of ₹ 500 lakhs filed on 18.02.2025, amount will be received in 10 years in equal instalments.

Since the release of subsidy is dependent on the budget allocation of State Government it is recognized in the books of accounts in the year of receipt. During the year Company has received a sum of ₹56.83 lakhs out of such subsidy as first installment which being the capital subsidy has been reduced from cost of the plant & machinery (refer note no.3 A)

- f. The Company vide letter no. 1 (4) /2025-SP dated 14.11.2025 received from, Government of India Ministry of Consumer affairs, Food & Public Distribution, Department of Food & Public Distribution is eligible for sugar export quota for 20406 MT. Out of above during the year has been swapped 15508 MT with domestic quota for ₹103.77 lakhs and 564 MT has been sold for ₹253.42 lakhs included in Revenue from Operations Note no. 25.

Government of India Ministry of Consumer affairs, Food & Public Distribution, Department of Food & Public Distribution issued notification no. 16/ 2026-27 dated 13th May 2026 for export of sugar prohibited with immediate effect till September 30, 2026. However, Company have further exported of sugar 273 MT during the F.Y. 2026-27.

- g. In pursuance to the Share Subscription Cum Transfer Agreement (SSTA) entered on 27.02.2024 with Uttamenergy Limited (UEL) and Uttam Distilleries Ltd. (UDL company had completed both tranches of investment i.e. first tranche by way of subscription of 29080000 equity shares of UDL for ₹.2908 Lakhs and second tranche by way of transfer of 16199100 equity shares of UDL from UEL ₹.2562.70 lakhs aggregating the total investment in 45279100 Equity shares of UDL (Subsidiary company) amounting to ₹ 5470.70 lakhs. (refer note no.4).

Further during the year company has also invested a sum of ₹1550.00 lakhs in 8% Non-cumulative redeemable preference shares of UDL. Out of this ₹1550.00 lakhs, ₹600.00 lakhs for working capital and ₹950.00 lakhs as promoter's contribution for expansion of the capacity. (refer note no.4)

- h. On November 21, 2025, the Government of India notified provisions 'Labour Codes' which consolidate twenty-nine existing labour laws into a unified framework governing employee benefits during employment and post-employment. The Company had assessed the financial implications of these changes which had resulted in increase in gratuity liability arising out of past service cost by ₹134.65 Lakhs. Considering the impact arising out of an enactment of the new legislation is an event of non-recurring nature, the company has presented this incremental amount as "Impact of Labour Codes" under "Exceptional Item" in the Statement of Profit and Loss for the year ended March 31, 2026.

- i. Regulatory fee @ ₹20 per quintal of molasses sales / inter-unit transfers imposed by the State Government of Uttar Pradesh w.e.f. 24th December, 2021 has been accounted for under protest as the company has challenged the same and the matter is pending with Hon'ble Allahabad High Court.

- j. The Uttar Pradesh Electricity Regulatory Commission (Captive and Renewal Energy Plants) Regulations, 2024 vide notification dated October 17, 2025 has revised power tariff with retrospective effect from April 1, 2024 for a period of five years. Accordingly, differential revenue due to revision of tariff has been accounted for in the above financial statements and consequently, revenue from operations for the year ended March 31, 2026 has increased by ₹ 739.79 lakhs (comprising ₹670.86 lakhs for the financial year 2024-25 and ₹68.93 lakhs pertaining to the current financial year). Refer note no. 25.

- k. a. The Board of Directors has proposed a dividend on 6.50% Redeemable Preference shares and on 10% Redeemable Preference shares and ₹2.50/- per equity share of ₹10/- each, for the year ended 31st March, 2026, which are subject to approval of Shareholders at the ensuing Annual General Meeting of the Company.
- b. During the year the Board of Directors has distributed a dividend for the year ended 31.03.2025 on 6.50% Redeemable Preference shares and on 10% Redeemable Preference shares aggregating of ₹90.13 Lakhs (Previous year ₹108.27 lakhs) and ₹2.50/- (Previous year ₹2.50/-) per equity share of ₹ 10/- each of ₹953.45 lakhs (Previous Year ₹953.45 Lakhs), after approval of Shareholders at the Annual General Meeting of the Company. Total cash outflow is ₹1029.08 lakhs (Previous Year ₹ 1059.62 Lakhs). Unpaid dividend as on date of Balance Sheet is ₹26.62 lakhs (Previous year ₹12.12 lakhs). (Refer Note No. 10 & 17).

o. The details of performance obligation in terms of Ind AS 115 - Revenue from contracts with customers are as follows:

Sugar:- The Sugar segment of the Company principally generates revenue from manufacturing and sale of sugar and its by-products and power. Domestic sales of sugar is made on ex-factory/delivery basis in terms agreed to wholesaler /institutional buyers/merchant exporters within the country. Domestic sugar sales are majorly done on advance payment terms. Export sales of sugar to merchant exporters are done on ex-factory /delivered basis in terms of the agreement and revenue is recognized when the goods have been shipped to / delivered to the buyers' specific location. The sale price and payment terms is fixed as per contracted terms.

Power is supplied to distribution companies from the Company's facilities in accordance with the sale price, payment terms and other conditions as per the Power Purchase Agreements ("PPA").

Bagasse are sold generally on advance payment terms on ex-factory basis as per the terms of the agreement and revenue is recognized when the goods have been shipped to / delivered to the buyer.

The distillery segment of the Company principally generates revenue from sale of industrial alcohol which mainly constitutes ethanol sold under contracts with Public and Private Oil Marketing Companies and other products to institutional buyers.

For sale of Ethanol, sale price is pre-determined based on Expression of Interest /Tender floated from Oil Marketing Companies. The prices are on delivered cost basis at Oil Marketing Companies locations inclusive of all duties/levies/taxes/charges etc. Payment terms is within 21 days after delivery of material and submission of original invoices.

Rectified Spirit, Extra Neutral Alcohol (ENA), etc. are sold on bulk basis to institutional buyers on ex-factory basis as per agreed terms. Revenue is recognized when goods have been shipped to the buyers' specific location as per agreed terms. The payment terms are fixed as per Company's policy which are generally on advance payment basis.

iii) Other risk

a) Regulatory risk

Sugar industry is regulated both by central government as well as by the state government, Central and state governments policies and factors such as State Advised Price (SAP) and fair and Remunerative Price (FRP) of sugar cane affects the sugar industry and the company's operations and profitability. Distillery business is also dependent on the Government policy as the price of ethanol decided by the Government. Similarly sugar prices are also effected by the Government Policies like restriction on sale, import of sugar by way of allocation of monthly Quota, export of sugar and import duty / export duty determination of sugar and MSP of sugar.

The regulatory risks listed above are Government policy driven and are beyond the control of the company and can't be alleviated unless the industry is decontrolled. Various representation through the body of industry like ISMA, UPSMA and UPDA submitted to Government to come out solutions regarding above risks.

Power business is also dependent on the regulations prescribed by Central/State regulatory commissions. They fix power purchase rates and other guide lines for supply based on cost of bagasse and other inputs.

b) Commodity price risk

Sugar Prices in domestic and international markets depends primarily on the supply and demand situation. Fluctuation in demand and supply arise on account of the change in the availability and price of sugar variation in the production capacity of the competitor's availability of substitutes for the sugar products and international demand and supply position. The company has mitigated this

risk by adding more value added products by diversifying into co-generation and distillation, thereby utilizing the by-products. Similarly, in sugar product also the company's products are diversifying in specialty sugar segments like brown sugar, sachet, pharma sugar, icing sugar, liquid sugar etc.

B. Credit Risk

Credit risk is the risk that counter party will default on its obligations under a Contractual arrangement leading to a financial loss. The company's sugar sales are mostly on advance payment basis. Power and ethanol are sold to state government companies and petroleum companies; thereby the credit default risk is significantly mitigated. Company has also taken advances and security deposits from its customers / agents, which mitigate the credit risk to an extent. Financial assets are written off when there is no reasonable expectation of recovery, however, the company continues to attempt to recover the receivables. Where recoveries are made, these are recognized in the statement of profit and loss.

Opinion

Notes on Consolidated Financial Statements for the year ended 31st March 2026

Note No. 1 : Corporate Information

Uttam Sugar Mills Ltd.– Holding Company (“USML” or the Company) is a public limited Company incorporated and domiciled in India. The registered office of the Company is situated at Village Libberheri, Tehsil Roorkee, Distt. Haridwar (Uttarakhand).

The Company's shares are listed on the BSE Limited and National Stock Exchange of India Ltd.

The Company is engaged in the manufacture and sale of Sugar, Industrial Alcohol and Generation of Power. The financial statements of the Company are for the year ended 31st March, 2026 and are prepared in Indian Rupees being the functional currency. The values in Rupees are rounded off to nearest rupee in lakhs up to two decimals, except otherwise indicated.

The company together with its subsidiary is hereafter represent to as ‘the Group’.

The consolidated financial statements for the year ended 31st March, 2026 was approved by the Board of Directors of the Company on 15th May 2026 and is subject to the adoption by the shareholders in the Annual General Meeting.

Uttam Distilleries Ltd.– Subsidiary Company is incorporated and domiciled in India. The registered office is situated at 7-C Ist Floor, J-Block Shopping Center, Saket, New Delhi, engaged in the manufacture of Industrial Alcohol.

The financial statements of subsidiary company for the year ended 31st March, 2026 was approved by the Board of Directors of the subsidiary company on 14th May 2026 and is subject to the adoption by the shareholders in the Annual General Meeting.

Note No. 2 : Material Accounting Policies

2.1 Statement of compliance with Ind AS

The consolidated financial statements of the group have been prepared to comply with the Indian Accounting Standards ('Ind AS') notified under Companies (Indian Accounting Standards) Rules, 2015 (as amended from time to time) read with Section 133 of the Companies Act, 2013 and other relevant provision and presentation requirement of Division II of Schedule III of the Companies Act as applicable.

The group has assessed the materiality of the accounting policy information which involves exercising judgements and considering both qualitative and quantitative factors by taking into account not only the size and nature of the item or condition but also the characteristics of the transactions, events or conditions that could make the information more likely to impact the decisions of the users of the financial statements.

Entity's conclusion that an accounting policy is immaterial does not affect the disclosures requirements set out in the accounting standards.

All the Ind AS issued and notified by the Ministry of Corporate Affairs under the Companies (India Accounting Standards) Rules 2015 (As amended) till the consolidated financial statements are approved for issue by the Board of Directors has been considered in preparing these financial statements.

2.2 Basis of preparation

These financial statements have been prepared in accordance with the provisions of the Companies Act, 2013, guidelines issued by Securities & Exchange Board of India (SEBI) and Indian Accounting Standard under the historical cost basis except for the following:-

- Certain financial assets and financial liabilities – measured at fair value and
- Defined benefits plan- plan assets measured at fair value.
- Biological assets that are measured at fair value, assets held for sale which is measured at lower of cost and fair value less cost to sell.

Accounting Policies have been consistently applied except where a newly issued IND AS is initially accepted or a revision to an existing IND AS requiring change in the accounting policies hitherto in use.

2.3 The group presents assets and liabilities in the consolidated balance sheet based on current/non-current classification.

An asset is treated as current when it is:

- Expected to be realized or intended to be sold or consumed in normal operating cycle,
- Held primarily for the purpose of trading,

- Expected to be realized within twelve months after the reporting period,
- Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period, or
- Carrying current portion of non-current financial assets.

All other assets are classified as non-current.

A liability is current when:

- It is expected to be settled in normal operating cycle,
- It is held primarily for the purpose of trading,
- It is due to be settled within twelve months after the reporting period,
- the group does not have a right at the end of the reporting period to defer settlement of the liability for at least twelve months after the reporting period.,
- The group's right to defer settlement of a liability for at least twelve months after the reporting period must exist at the end of the reporting period. Classification of a liability is unaffected by the likelihood that the group will exercise its right to defer settlement.
- Where the right to defer settlement is subject to compliance with covenants, such right exists only if the group complies with those covenants on or before the end of the reporting period where testing of such covenants is required on or before the end of the reporting period.
- It includes current portion of non-current financial liabilities.

All other liabilities are classified as non-current.

2.4 Principal of consolidation

The consolidated financial statements comprise the financial statements of Uttam Sugar Mills Limited (hereinafter referred to as “the Holding Company”) and its subsidiary. The Holding Company together with its subsidiary constitute “the Group”. For this purpose, an entity which is directly or indirectly, controlled by the Holding Company is treated as subsidiary. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee. Specifically, the Group controls an investee if and only if the Group has:

- Power over the investee (i.e. existing rights that give it the current ability to direct the relevant activities of the investee),
- Exposure, or rights, to variable returns from its involvement with the investee, and
- The ability to use its power over the investee to affect its returns. Generally, there is a presumption that a majority of voting rights result in control. To support this presumption and when the Group has less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:
 - The contractual arrangement with the other vote holders of the investee
 - Rights arising from other contractual arrangements
 - The Group's voting rights and potential voting rights
 - The size of the group's holding of voting rights relative to the size and dispersion of the holdings of the other voting rights holders.

The Group re-assesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control.

Investment in subsidiary:

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Assets, liabilities, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated financial statements from the date the Group gains control until the date the Group ceases to control the subsidiary.

Consolidated financial statements are prepared using uniform accounting policies for like transactions and other events in similar circumstances. If a member of the Group uses accounting policies other than those adopted in the consolidated financial statements for like transactions and events in similar circumstances, appropriate adjustments are made to that Group member's financial statements in preparing the consolidated financial statements to ensure conformity with the Group's accounting policies.

The financial statements of all entities used for the purpose of consolidation are drawn up to same reporting date as that of the parent company, i.e., year ended on 31 March. When the end of the reporting period of the parent is different from that of a subsidiary, the subsidiary prepares, for consolidation purposes, additional financial information as of the same date as the financial statements of the parent to enable the parent to consolidate the financial information of the subsidiary, unless it is impracticable to do so. Consolidation procedure:

- The financial statement of the group companies is consolidated on line to line basis by combine like items of assets, liabilities, equity, income, expenses and cash flows of the parent with those of its subsidiary.
- Offset (eliminate) the carrying amount of the parent's investment in each subsidiary and the parent's portion of equity of each subsidiary. Business combinations policy explains how to account for any related goodwill.
- Eliminate in full intra group assets and liabilities, equity, income, expenses and cash flows relating to transactions between entities of the Group (profits or losses resulting from intra group transactions that are recognized in assets, such as inventory and fixed assets, are eliminated in full). Intra group losses may indicate an impairment that requires recognition in the consolidated financial statements. IND AS 12 Income Taxes applies to temporary differences that arise from the elimination of profits and losses resulting from intra group transactions. Profit or loss and each component of other comprehensive income (OCI) are attributed to the equity holders of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. When necessary, adjustments are made to the financial statements of subsidiary to bring their accounting policies into line with the Group's accounting policies. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction. If the Group loses control over a subsidiary, it:

- Derecognizes the assets (including goodwill) and liabilities of the subsidiary
- Derecognizes the carrying amount of any non-controlling interests
- Derecognizes the cumulative translation differences recorded in equity
- Recognizes the fair value of the consideration received
- Recognizes the fair value of any investment retained
- Recognizes any surplus or deficit in profit or loss
- Reclassifies the parent's share of components previously recognized in OCI to profit or loss or retained earnings, as appropriate, as would be required if the Group had directly disposed of the related assets or liabilities.

Summary of Material Accounting Policies:-

2.5 Business Combinations and Goodwill

Business combinations are accounted for using the acquisition method under the provisions of Ind AS 103 i.e. Business Combinations.

The cost of an acquisition is measured at the aggregate of the consideration transferred measured at acquisition date fair value and the amount of any non-controlling interests in the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree.

at fair value or at the proportionate share of the acquiree's identifiable net assets. Acquisition-related costs are expensed as incurred.

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognized at their acquisition date fair values. For this purpose, the liabilities assumed include contingent liabilities representing present obligation and they are measured at their acquisition fair values irrespective of the fact that outflow of resources embodying economic benefits is not probable. However, the following assets and liabilities acquired in a business combination are measured at the basis indicated below:

- Deferred tax assets or liabilities, and the assets or liabilities related to employee benefit arrangements are recognized and measured in accordance with Ind AS 12 Income Tax and Ind AS 19 Employee Benefits respectively.
- Assets (or disposal groups) that are classified as held for sale in accordance with Ind AS 105 Non-current Assets Held for Sale and Discontinued Operations are measured in accordance with that standard. When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts by the acquiree.

If the business combination is achieved in stages, any previously held equity interest is re-measured at its acquisition date fair value and any resulting gain or loss is recognized in profit or loss or OCI, as appropriate.

Any contingent consideration to be transferred by the acquirer is recognized at fair value at the acquisition date. Contingent consideration classified as an asset or liability that is a financial instrument and within the scope of Ind AS 109 Financial Instruments, is measured at fair value with changes in fair value recognized in profit or loss. If the contingent consideration is not within the scope of Ind AS 109, it is measured in accordance with the appropriate Ind AS. Contingent consideration that is classified as equity is not re-measured at subsequent reporting dates and subsequent its settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred and the amount recognized for non-controlling interests, and any previous interest held, over the net identifiable assets acquired and liabilities assumed. If the fair value of the net assets acquired is in excess of the aggregate consideration transferred, the Group re-assesses whether it has correctly identified all of the assets acquired and all of the liabilities assumed and reviews the procedures used to measure the amounts to be recognized at the acquisition date. If the reassessment still results in an excess of the fair value of net assets acquired over the aggregate consideration transferred, then the gain is recognized in OCI and accumulated in equity as capital reserve. However, if there is no clear evidence of bargain purchase, the entity recognises the gain directly in equity as capital reserve, without routing the same through OCI.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units that are expected to benefit from the combination, irrespective of whether other assets or liabilities of the acquiree are assigned to those units. A cash generating unit to which goodwill has been allocated is tested for impairment annually, or more frequently when there is an indication that the unit may be impaired. If the recoverable amount of the cash generating unit is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill allocated to the unit and then to the other assets of the unit pro rata based on the carrying amount of each asset in the unit. Any impairment loss for goodwill is recognized in profit or loss. An impairment loss recognized for goodwill is not reversed in subsequent periods.

Where goodwill has been allocated to a cash-generating unit and part of the operation within that unit is disposed of, the goodwill associated with the disposed operation is included in the carrying amount of the operation when determining the gain or loss on disposal. Goodwill disposed in these circumstances is measured based on the relative values of the disposed operation and the portion of the cash-generating unit retained.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted through goodwill during the measurement period, or additional assets

or liabilities are recognized, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognized at that date. These adjustments are called as measurement period adjustments. The measurement period does not exceed one year from the acquisition date.

2.6 Revenue recognition

Revenue from sale of product is recognized at the point in time when control of the goods is transferred to the customer, generally on delivery of the product.

At contract inception, the Group assess the goods promised in a contract with a customer and identify as a performance obligation each promise to transfer to the customer. Revenue from contracts with customers is recognized when control of goods or services are transferred to customers and the Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold.

Revenue is measured at the fair value of the consideration received or receivables, net of returns and allowances, trade discounts and volume rebates. Revenue is recognized to the extent that it is probable that the economic benefits will flow to the Group and the revenue can be reliably measured, regardless of when the payment is being made.

Revenue is measured at the fair value of the consideration received or receivable, taking into account contractually defined terms of payment and excluding taxes or duties collected on behalf of the Government. The Group bases its estimates on historical results, taking into consideration the type of customer, the type of transaction and the specific of each arrangement.

Revenue from sale of power is recognized when the units generated are transmitted to the pooling station, in accordance with the terms and conditions of the power purchase agreement entered into by the Group with the purchasing parties.

Income from sale of REC is recognized on delivery of REC to the customers 'account.

Export incentives are accounted for in the year of exports based on eligibility and when there is no significant uncertainty in receiving the same.

Interest income from a financial asset is recognized when it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the "effective interest rate" that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's gross carrying amount.

Insurance claims are accounted for on the basis of claims admitted / expected to be admitted and to the extent that there is no uncertainty in receiving the claims.

All other incomes are accounted for on accrual basis.

2.7 Expenses

All expenses are accounted for on accrual basis.

2.8 Property, plant and equipment and Capital work in progress (CWIP)

All property, plant and equipment are measured at cost less accumulated depreciation and accumulated impairment losses, if any. Free hold land is not depreciated. The cost of an asset includes the purchase cost of materials, including import duties and non-refundable/ creditable taxes and any directly attributable cost of bringing an asset to the location and condition of its intended use and costs of dismantling and removing the item and restoring the site on which it is located, interest on borrowing used to finance the construction of qualifying assets are capitalized as part of the cost of the asset until such time that the asset is ready for its intended use.

When significant parts of property, plant and equipment are required to be replaced at intervals, the Group depreciates them separately based on their specific useful lives. Likewise, when a major refurbishment is performed, its cost is recognized in the carrying amount of the plant and equipment as a replacement if the recognition criteria are satisfied. All other repairs and maintenance costs are recognized in statement of profit and loss as incurred.

Items of spare parts, stand-by equipment and servicing equipment which meet the definition of property, plant and equipment are capitalized. Other spare parts are carried as inventory and recognized in the statement of profit and loss on consumption. When parts of an item of PPE have different useful lives, they are accounted for as separate component.

Directly attributable expenditure (including finance cost relating to borrowed funds for construction or acquisition of fixed assets) incurred on projects under implementation are treated as pre-operative expenses pending allocation to the assets and are shown under CWIP, CWIP is stated at the amount expended up to balance sheet date on assets or property, plant and equipment that are not yet ready for their intended use.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment.

The cost and related accumulated depreciation are eliminated from the financial statements upon disposal/sale or retirement of the asset and the resultant gains or losses (difference between the sale proceeds and the carrying amount of the assets) are recognized in the Statement of profit and Loss.

2.9 Intangible assets (Computer software)

Intangible assets are stated at cost of acquisition net of recoverable taxes less accumulated amortization/depletion and impairment loss, if any. The cost comprises purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for the intended use. An intangible asset is derecognized on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from de-recognition of an intangible asset are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognized in the Statement of profit and loss when the asset is derecognized.

2.10 Depreciation methods, estimated useful lives and residual value

- Depreciation on property, plant and equipment is provided on Straight Line basis so as to charge the cost of the assets or the amount substituted for costs in case of revalued assets less its residual value over the useful life of the respective asset as prescribed under part C of Schedule II to the Companies Act, 2013. Residual value has been considered as 5% of the cost of the respective assets.
- Leasehold Building Developments are amortized at lower of period of lease or ten years.
- Intangible Assets are amortized over a period of economic benefits not exceeding ten years.
- Depreciation/amortization on assets added, sold or discarded during the year is provided on pro – rata basis.

2.11 Inventories

Inventories (other than By-products) are valued at lower of cost or net realizable value.

Inventories of Renewal Energy Certificates (REC) are valued at lower of cost or net realizable value.

Inventories on stock in trade are valued at lower of cost or net realizable value.

Cost of inventories has been determined on current cost.

Chemicals, packing material and other store & spares at purchase cost including incidental expenses on -weighted average basis.

Cost of finished goods and Work in Progress has been worked out on absorption cost basis.

By- products and residuals are valued at net realizable value except in case of B Heavy Molasses which is valued by considering the realizable value of C Heavy Molasses plus sugar sacrificed for producing B Heavy Molasses.

Net realizable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and estimated costs necessary to make the sale.

Assessment of net realizable value is made at each subsequent reporting date. When the circumstances that previously caused inventories to be written down below cost no longer exist or when there is clear evidence of an increase in net realizable value because of changed economic circumstances, the amount so written-down is adjusted in terms of policy as stated above.

2.12 Government Grants

Government grants are recognized at fair value when there is reasonable assurance that the grant would be received and the Group would comply with all the conditions attached with them.

Government grants related to property, plant and equipment are treated as deferred revenue (included under non-current liabilities with current portion considered under current liabilities) and are recognized and credited in the statement of profit and loss on systematic and rational basis and included under other income.

Government grants related to revenue nature are recognized on a systematic basis in the Statement of profit and Loss over the periods necessary to match them with the related costs which they are intended to compensate and are adjusted with the related expenditure.

(If not related to a specific expenditure, it is taken as income and presented under: other Income)

2.13 Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of assets are capitalized as part of the cost of such assets. A qualifying asset is one that necessarily takes substantial period of time to get ready for its intended use. Interest income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalization. All other borrowing costs are charged to the profit and loss statement in the period in which they are incurred.

Preference Shares, which are mandatorily redeemable on a specific date are classified as liabilities. The dividend on these preference shares is recognized as finance cost in the Statement of Profit and Loss.

2.14 Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. That is, if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

As a lessee the Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognizes lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

Right-of-use assets The Group recognizes right-of-use assets at the commencement date of the lease (i.e., the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any re-measurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognized, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received.

Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease term and the estimated useful lives of the assets. If ownership of the leased asset transfers to the Group at the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset. The right-of-use assets are also subject to impairment.

The right-of-use assets are disclosed in Property, Plant and Equipment (see Note 3).

Lease Liabilities At the commencement date of the lease, the Group recognizes lease liabilities measured at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is re-measured if there is a modification, a change in the lease term, a change in the lease payments (e.g., changes to future payments resulting from a change in an index or rate used to determine such lease payments) or a change in the assessment of an option to purchase the underlying asset. Lease liabilities are included in Other financial liabilities.

Short-term lease and lease of low-value assets The Group applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (i.e., those leases that have a lease term of twelve months or less from the commencement date and do not contain a purchase option). It also applies the lease of low-value assets recognition exemption to leases of offices, godowns, equipment, etc. that are of low value. Lease payments on short-term leases and leases of low-value assets are recognized as expense on a straight-line basis over the lease term.

2.15 Provisions, contingent liabilities and contingent assets.

Provisions involving substantial degree of estimation in measurement are recognized when there is a present obligation as a result of past events and it is probable that there will be an outflow of resources.

If the effect of the time value of money is material, provisions are determined by discounting the expected future cash flows at current pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability when discounting is used, the increase in the passage of time is recognized as finance costs.

A contingent liability is a possible obligation that arises from past events whose existence will be confirmed by the occurrence or non-occurrence of one or more uncertain future events beyond the control of the Group or a present obligation that is not recognized because it is not probable that an out flow of recourses will be required to settle the obligation. A contingent liability also arises in extremely rare cases where there is liability that can't be recognized because it can't be measured reliably.

A contingent liability is not recognized in the financial statements, but discloses its existence in the Financial Statement

When the realization of income is virtually certain, then the related asset is no longer a contingent asset, and is recognized as an asset.

Provisions, contingent liabilities and contingent assets are reviewed at each balance sheet date.

2.16 Dividend payable

Final dividend on shares is recorded as a liability on the date of approval by the shareholders and interim dividend are recorded as a liability on the date of declaration by the Group's Board of Directors. A corresponding amount is recognized directly in equity.

2.17 Foreign currency transactions

Transactions in foreign currency are recorded at the exchange rate prevailing on the date of transaction. Monetary items denominated in foreign currencies at the year ended translated at the year ended rates which is likely to be realized from, or required to disburse at the balance sheet date. Exchange differences arising on settlement of monetary items at rates different from those at which they were initially recorded / reported in financial statements are recognized as income or expense in the year in which they arise.

Non-monetary items which are carried at historical cost denominated in a foreign currency are translated using the exchange rate at the date of the initial transaction.

2.18 Employee benefits

- Short-term employee benefits are recognized as an expense at the undiscounted amount in the Statement Profit & Loss Account of the period in which the related service is rendered.
- Long-term employee benefits are recognized as an expense in the Statement Profit & Loss Account for the year in which the employee has rendered services.

Defined Benefit Plans

The Group's liabilities on account of gratuity and earned leaves on retirement of employees are determined at the end of each financial year on the basis of actuarial valuation certificates obtained from registered actuary in accordance with the measurement procedure as per Indian Accounting Standard (INDAS)-19- 'Employee Benefits'.

i) Compensated absences

Accumulated leave, which is expected to be utilized within next 12 months, is treated as short term employee benefit and this is shown under current provisions in the Balance Sheet. The Group treats accumulated leave expected to be carried forward beyond twelve months, as long-term employee benefits and shown under long term provisions in the Balance sheet.

ii) Gratuity

The Group provides for retirement benefits in the form of gratuity. The Group's liability towards this benefit is determined on the basis of actuarial valuation using projected unit credit method at the date of Balance sheet. Actuarial gain and Losses in respect of such benefits are recognized in Other Comprehensive Income.

2.19 Financial instruments

A Financial instrument is any contract that gives rise to financial assets of one entity and a financial liability or equity instrument of another party.

A. Financial Assets

a. Initial recognition

The Group classifies financial instruments, or their component parts, on initial recognition as a financial asset, a financial liability or an equity instrument in accordance with the substance of the contractual arrangement. Financial instruments are recognized when the Group becomes a party to the contractual provisions of the instrument. Financial instruments are recognized initially at fair value plus transactions costs that are directly attributable to the acquisition or issue of the financial instrument, except for financial assets at fair value through statement of profit and loss, which are initially measured at fair value, excluding transaction costs (which is recognized in statement of profit and loss).

b. Subsequent measurement

i) Financial assets carried at amortized cost (AC)

A financial asset is subsequently measured at amortized cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

ii) Financial assets at fair value through other comprehensive income (FVTOCI)

A financial asset is subsequently measured at fair value through other comprehensive income if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

iii) Financial assets at fair value through statement of profit and loss (FVTPL)

Equity instruments

All equity investments in scope of Ind AS 109 are measured at fair value either as at FVTOCI or FVTPL. The Group makes such election on instrument-by-instrument basis. For equity instruments measured as at FVTOCI, all fair value changes on the instrument, excluding dividends, are recognized in the OCI. Equity instruments included within the FVTPL category are measured at fair value with all changes recognized in the Statement of Profit & Loss account.

c. De-recognition

A Financial Assets (or where applicable, part of financial assets) is primarily derecognized when:

1. The contractual right to receive cash flows from the assets have expired or
2. The Group has transferred its right to receive cash flow from the financial assets and subsequently all the risks and rewards of ownership of the assets to third party.

d. Reclassification of financial assets:

Group determines the classification of financial assets and liabilities on initial recognition. After initial recognition, no reclassification is made for financial assets which are equity instruments and financial liabilities.

e. Impairment of financial assets

The Group recognized loss allowance using the expected credit loss (ECL) model for the financial assets which are not fair valued through Statement of Profit and loss. Loss allowance for trade receivable with no significant financing component is measured at an amount equal to life time ECL.

For all other financial assets, expected credit loss are measured at an amount equal to the twelve-month ECL, unless there has been a significant increase in credit risk from initial recognition in which case those are measured at lifetime ECL.

B. Financial liabilities

a. Initial recognition and measurement:

All financial liabilities are recognized initially at fair value and in case of loans and borrowings and payables, net of directly attributable cost. The Group's financial liabilities include trade and other payable, loans and borrowing including bank over drafts, financial guarantee contracts and derivative financial instruments. Fees of recurring nature are directly recognized in statement of profit and loss as finance cost.

b. Subsequent measurement:

Financial liabilities are subsequently carried at amortized cost using the effective interest method. For trade and other payables maturing within one year from the balance sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

i) Loans and borrowings

After initial recognition, interest bearing loans and borrowings are subsequently measured at amortized cost using the effective interest rate (EIR) method. Gains and losses are recognized in statement of profit and loss when liabilities are de-recognized. Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortization is included as finance cost in the statement of profit and loss.

ii) Compound financial instruments

At the issue date the fair value of the liability component of a compound instrument is estimated using the market interest rate for a similar non-convertible instrument. This amount is recorded as a liability at amortized cost using the effective interest method until extinguished upon conversion or at the instrument's redemption date. The equity component is determined as the difference of the amount of the liability component from the fair value of the instrument. This is recognized in equity, net of income tax effects, and is not subsequently re-measured.

c. De-recognition of financial instruments

A financial liability is derecognized where the obligation under the liability is discharged or cancelled or expires where an existing financial liability is replaced by another from the same tender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the de-recognition of the original liability and the recognition of new liability. The difference in the respective carrying amounts is recognized in the statement of Profit and Loss.

d. Offsetting of financial instruments

Financial assets and financial liabilities including derivative instruments are offset and the net amount is reported in the Balance sheet, if there is a currently enforceable legal right to offset the recognized amounts and there is an intention to settle on a net basis or to realize the assets and settle the liabilities simultaneously.

e. Fair value measurement

Fair value is a market-based measurement, not an entity-specific measurement. Under Ind AS, fair valuation of financial instruments is guided by Ind AS 113 "Fair Value Measurement" (Ind AS – 113).

For some assets and liabilities, observable market transactions or market information might be available. For other assets and liabilities, observable market transactions and market information might not be available. However, the objective of a fair value measurement in both cases is the same to estimate the price at which an orderly transaction to sell the asset or to transfer the liability would take place between market participants at the measurement date under current market conditions (i.e. an exit price at the measurement date from the perspective of a market participant that holds the asset or owes the liability).

Three widely used valuation techniques specified in the said Ind AS are the market approach, the cost approach and the income approach which have been dealt with separately in the said Ind AS.

Each of the valuation techniques stated as above proceeds on different fundamental assumptions, which have greater or lesser relevance, and at times there is no relevance of a particular methodology to a

given situation. Thus, the methods to be adopted for a particular purpose must be judiciously chosen. The application of any particular method of valuation depends on the Group being evaluated, the nature of industry in which it operates, the Group's intrinsic strengths and the purpose for which the valuation is made.

In determining the fair value of financial instruments, the Group uses a variety of methods and assumptions that are based on market conditions and risks existing at each balance sheet date.

The Group uses the following hierarchy for determining and disclosing the fair value of financial instruments by valuation technique:

Level 1: Quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3: Inputs for the assets or liabilities that are not based on observable market data (unobservable inputs)

f. Share capital

An equity instrument is a contract that evidences residual interest in the assets of the Group after deducting all of its liabilities. Incremental costs directly attributable to the issuance of new equity shares are recognized as a deduction from equity, net of any tax effects.

2.20 Impairment Non-financial assets

The carrying amount of any property, plant and equipment and intangible assets with finite lives are reviewed at each balance sheet date, if there is any indication of impairment based on internal /external factor. An asset is impaired when the carrying amount of the asset exceeds the recoverable amount. Recoverable amount is higher of an asset's or cash generating unit's net selling price and its value in use. Recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or group of assets.

An impairment loss is charged to the Statement of Profit and loss in the year in which an asset is identified as impaired. An impairment loss recognized in prior accounting periods is reversed if there has been change in the estimate of the recoverable amount. At each balance sheet date, the Group assesses whether there is any indication that any property, plant and equipment and intangible assets with finite lives may be impaired. If any such impairment exists, the recoverable amount of an asset is estimated to determine the extent of impairment. If at the balance sheet date there is an indication that a previously assessed impairment loss no longer exists, the recoverable amount is reassessed and the impairment loss previously recognized is reversed such that the asset is recognized at its recoverable amount but not exceeding written down value which would have been reported if the impairment loss had not been recognized.

2.21 Taxes

Income tax expense comprises current tax and deferred tax and is recognized in the Statement of Profit and Loss except to the extent it relates to items directly recognized in Equity or in Other Comprehensive Income (OCI).

Current tax

Provision for current tax is made with reference to taxable income computed for the accounting period for which the financial statements are prepared by applying the tax rates and laws that are enacted or substantively enacted at the balance sheet date. The tax is recognized in statement of profit and loss, except to the extent that it related to items recognized in the OCI or in other equity. In this case, the tax is also recognized in other comprehensive income and other equity.

The Group offsets current tax assets and current tax liabilities, where it has a legally enforceable right to set off the recognized amounts and where it intends either to settle on a net basis or to realize the assets and settle the liabilities simultaneously.

Deferred tax

Deferred tax is recognized using the balance sheet approach. Deferred tax assets and liabilities are recognized for deductible and taxable temporary differences arising between the tax base of assets and liabilities and their carrying amount in financial statements, except when the deferred tax arises from the initial recognition of

goodwill or an asset or liability in a transaction that is not a business combination and affects neither accounting nor taxable profits or loss at the time of the transaction.

Deferred tax assets are recognized for deductible temporary differences, the carry forward of and any unused tax losses to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carry forward of unused tax losses can be utilized. .

The carrying amount of deferred tax assets is reviewed at each balance sheet date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax assets to be recovered.

Unrecognized deferred tax assets are re-assessed at each balance sheet date and are recognized to the extent that it has become probable that future taxable profits will allow the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the year when the asset is realized or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the balance sheet date.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off deferred tax assets against deferred tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority.

2.22 Earnings per Share

The Group presents basic and diluted earnings per share ("EPS") data for its equity shares. Basic EPS is calculated by dividing the profit/loss before other comprehensive income/loss for the year attributable to equity shareholders of the Group by the weighted average number of equity shares outstanding during the period. Diluted EPS is determined by adjusting the profit/loss before other comprehensive income/loss for the year attributable to equity shareholders and the weighted average number of equity shares outstanding for the effects of all dilutive potential equity shares.

2.23 Non-current assets (or disposal groups) held for sale and discontinued operations

(a) Non-current assets (or disposal groups) are classified as held for sale if their carrying amount would be recovered principally through a sale/distribution rather than through continuing use and a sale/distribution is considered highly probable.

Actions required to complete the sale/distribution should indicate that it is unlikely that significant changes to the sale/ distribution would be made or that the decision to sell/distribute would be withdrawn. Management must be committed to sale/distribution expected within one year from the date of classification.

(b) Immediately before the initial classification of the assets (and disposal groups) as held for sale, the carrying amount of the assets (or all the assets and liabilities in the disposal groups) are measured in accordance with their applicable accounting policy.

Non-current assets (or disposal groups) held for sale/for distribution to owners are subsequently measured at the lower of their carrying amount and fair value less costs to sell, except for assets such as deferred tax assets, assets arising from employee benefits and financial assets which are specifically exempt from this requirement.

(c) Non-current assets including those that are part of a disposal group (PPE and Intangible assets) once classified as held for sale/ distribution to owners are neither depreciated nor amortized. Interest and other expenses attributable to the liabilities of a disposal group classified as held for sale continue to be recognized.

(d) Non-current assets (including assets of a disposal group) classified as held for sale are presented separately from the other assets in the Balance sheet. The liabilities of a disposal group classified as held for sale/ distribution are presented separately from other liabilities in the Balance sheet.

(e) A disposal group qualifies as discontinued operation, if it is a component of equity that has either being disposed of or is classified as Held for sale, and that represents a separate major line of business or geographical area of operations, or is part of a single co-ordinate plan to dispose of a separate major line of business or geographical area of operations or is a subsidiary exclusively with a view to resale.

Discontinued operations are excluded from the results of continuing operations and are presented separately as a single amount as profit or loss after tax from discontinued operations in the Statement of Profit and Loss and comparative information is restated accordingly.

(f) All notes to the financial statements mainly include amounts for continuing operations, unless stated otherwise

2.24 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. Revenue and expenses are identified to segments on the basis of their relationship to the operating activities of the segment. Inter segment revenue are accounted for based on the cost price. Revenue, expenses, assets and liabilities which are not allocable to segments on a reasonable basis, are included under "Unallocated revenue/ expenses/ assets/ liabilities". The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Managing Director who makes strategic decisions.

The accounting policies adopted for segment reporting are in line with the accounting policies adopted for preparing and presenting the financial statements of the Group as a whole.

2.25 Cash and cash equivalents

Cash and cash equivalents in the consolidated Balance sheet comprise cash on hand, cheques on hand, balance with banks on current accounts and debit balance of cash credit account if any and short term, highly liquid investments with an original maturity of three months or less and which carry insignificant risk of changes in value.

For the purpose of the consolidated Cash Flow Statement, Cash and cash equivalents consist of Cash and cash equivalents, as defined above and net of outstanding book overdrafts as they are considered an integral part of the Group's cash management.

2.26 Cash Flow Statement

Cash flows are reported using the indirect method, whereby profit/loss before tax is adjusted for the effects of transactions of a non-cash nature, any deferrals or accruals of past or future operating cash receipts or payments and item of income or expenses associated with investing or financing flows. The cash flows from operating, investing and financing activities of the Group are segregated.

Note No. : 2A Key accounting judgment, estimates and assumptions

The preparation of the financial statements requires the use of accounting estimates, which, by definition would seldom equal the actual results. Management also needs to exercise judgment and make certain assumptions in applying the Group accounting policies and preparation of financial statements.

The use of such estimates, judgments and assumptions affects the reported amounts of revenue, expenses, assets and liabilities including the accompanying disclosures and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in the future periods.

Estimates and judgments are continually evaluated. They are based on historical experience and other factors including expectations of future events that may have a financial impact on the Group and that are believed to be reasonable under the circumstances.

Estimates and Assumptions

The Group has based its assumptions and estimates on parameters available when the financial statement was prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising that are beyond the control of the Group. Such changes are reflected in the assumptions when they occur.

The key assumptions concerning the future and other key sources of estimation uncertainty at the balance sheet date that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are described below.

- i) **Depreciation and useful lives of property, plant and equipment:** Property, plant and equipment are depreciated over the estimated useful lives of the assets, after taking into account their estimated residual value. Management reviews the estimated useful lives and residual values of the assets annually in order to determine the amount of depreciation to be recorded during any reporting period. The useful lives and residual values are based on the Group's historical experience with similar assets and take into account anticipated technological changes. The depreciation for future periods is adjusted if there are significant changes from previous estimates.
- ii) **Income Tax:** Management judgment is required for calculation of income tax and deferred tax assets and liabilities. Deferred tax assets are recognized for unused losses (carry forward of prior years' losses) to the extent that it is probable that taxable profit would be available against which the losses could be utilized.

The Group reviews at each balance sheet date the carrying amount of deferred tax. The factor used in estimate may differ from actual outcome which may lead to significant adjustment in the amounts in financial statement.

- iii) **Recoverability of trade receivable:** Judgments are required in assessing the recoverability of overdue trade receivables and determining whether a provision against those receivables is required. Factors considered include the credit rating of the counterparty, the amount and timing of anticipated future payments and any possible actions that can be taken to mitigate the risk of non-payment.
- iv) **Provisions for contingencies:** Provisions are recognized in the period when it becomes probable that there will be a future outflow of funds resulting from past operations or events and the amount of cash outflow can be reliably estimated. The timing of recognition and quantification of the liability require the application of judgment to existing facts and circumstances, which can be subject to change. Since the cash outflows can take place many years in the future, the carrying amounts of provisions and liabilities are reviewed regularly and adjusted to take account of changing facts and circumstances.
- v) **Impairment of non-financial assets:** The Group assesses at each reporting date whether there is an indication that an asset may be impaired. If any indication exists, or when annual impairment testing for an asset is required, the Group estimates the asset's recoverable amount. An asset's recoverable amount is the higher of an asset's or CGU's fair value less costs of disposal and its value in use. It is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. Where the carrying amount of an asset or CGU exceeds its recoverable amount, the asset is considered impaired and is written down to its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using pretax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. In determining fair value less costs of disposal, recent market transaction are taken into account, if no such transactions can be identified, an appropriate valuation model is used.
- vi) **Estimation of Defined benefit obligations:** The Group's obligation on account of gratuity and compensated absences is determined based on actuarial valuation.
An actuarial valuation involves making various assumptions that may differ from actual developments in the future. These include the determination of the discount rate, future salary increases and mortality rates. Due to the complexities involved in the valuation and its long-term nature, a defined benefit obligation is highly sensitive to changes in these assumptions. All assumptions are reviewed at each financial year end.
- vii) **Impairment of financial assets:** The impairment provisions for financial assets are based on assumptions about risk of default and expected cash loss rates. The Group uses judgment in making these assumptions and selecting the inputs to the impairment calculation, based on Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period.
- viii) **Fair value measurement of financial instruments:** When the fair value of the financial assets and liabilities recorded in the balance sheet cannot be measured based on the quoted market price in activate markets, their fair value is measured using valuation technique. The input to these models are taken from the observable market where possible, but if this is not feasible, a review of judgment is required in establishing fair values. Changes in assumption relating to this assumption could affect the fair value of financial instrument.
- ix) **Material uncertainty about going concern:** In preparing financial statements, management has made an assessment of Group's ability to continue as a going concern. Financial statements are prepared on a going concern basis. The Management is aware, in making its assessment, of material uncertainties related to events or conditions that may cast significant doubt upon the Group's ability to continue as a going concern.

Recent pronouncements

Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time.

In May 2025, MCA notified amendments to Ind AS 21 - The Effects of Changes in Foreign Exchange Rates, applicable w.e.f. April 1, 2025. The Ministry of Corporate Affairs (MCA) notified the Companies (Indian Accounting Standards) Amendment Rules, 2025, which amend Ind AS 21, The Effects of Changes in Foreign Exchange Rates to specify how an entity should assess whether a currency is exchangeable and how it should determine a spot exchange rate when exchangeability is lacking. The amendments also require disclosure of information that enables users of its consolidated Financial Statements to understand how the currency not being exchangeable into the other currency affects, or is expected to affect, the entity's financial performance, financial position and cash flows.

The Group has reviewed the amendment and based on its evaluation has determined that it does not have any impact in its financial statements.

In August 2025, MCA notified the following amendments to:

1. Ind AS 1, Presentation of Financial Statements, applicable w.e.f. April 1, 2025 –

The amendment relates to classification of liabilities as current or non-current and non-current liabilities with covenants. In the context of classifying a liability as current, it removes the requirement of existence of a right to defer settlement for at least 12 months after the reporting date and instead requires that the said right should exist on the reporting date and have substance. The amendment also introduces guidance on classification of liabilities with covenants.

A requirement has been introduced to require disclosure when a liability arising from a loan agreement is classified as non-current and the entity's right to defer settlement is contingent on compliance with future covenants within twelve months

If there is a breach of a material covenant of a long term loan arrangement on or before the end of the reporting period, resulting in the liability becoming payable on demand as at the reporting date, and the lender agrees—after the reporting period but before the consolidated Financial Statements are approved for issue—not to demand repayment for at least 12 months as a consequence of the breach, this shall be treated as an adjusting event. Accordingly, the entity is not required to classify the liability as current. The amendments are effective for annual reporting periods beginning on or after 1 April 2025 retrospectively in accordance with Ind AS 8

The Group has no impact of these amendments in its classification criteria of current and non-current liabilities.

2. Ind AS 7, Statement of Cash Flows and Ind AS 107, Financial Instruments: Disclosures, applicable w.e.f. April 1, 2025 –

The amendment in Ind AS 7 requires to inform users of Consolidated Financial Statements of the existence of supplier finance arrangements and explain the nature of the arrangements, the carrying amount of liabilities and the range of payment due dates. Ind AS 107 has been amended to add supplier finance arrangements as a factor that may cause concentration of liquidity risk. Since the group does not have any supplier finance arrangement the same is not applicable to the company

Ind AS 12, International Tax Reform – Pillar Two Model Rules applicable immediately - The amendments provide a temporary mandatory relief from deferred tax accounting for top-up tax and disclose that they have applied the relief. The amendments had no impact on the Group's Consolidated Financial Statements as the Group is not in scope of the Pillar Two model rules.

- b. All the Current assets, loans and advances of the group, in the opinion of the Board, have a value on realization which in the ordinary course of business shall at least be equal to the amount at which it is stated in the balance sheet.
- c. The holding company has made an investment of the requisite amount for setting up new projects in the State of Uttar Pradesh in accordance with the UP Sugar Industry Promotion Policy, 2004 and has accordingly filed application for eligibility under the above policy. However, the State Government has later on terminated the Policy with effect from June 4, 2007. The holding Company had filed writ petition before Hon'ble Allahabad high court (Lucknow Bench) for enforcement of the scheme and settlement of incentive claims.
- The writ petitions were allowed vide common Judgment dated 12.02.2019 of Hon'ble Allahabad High court (Lucknow Bench) that the petitioners are entitled for consideration of all the benefits in the form of exemptions/ remission/ reimbursements as per the Sugar Industry Promotion Policy – 2004 and various notifications issued thereunder from time to time for the entire period of the validity of the Policy. As per Hon'ble court, Since the matter has become quite old it will be appropriate that the cases may be examined and benefits may be given within a maximum period of two months from the date of order.
- The State Government has challenged the order of the Hon'ble Allahabad High court (Lucknow Bench) in Supreme Court where their petition has been admitted, and now the matter is pending with Supreme Court.
- However, the holding company have submitted the claim on 4th September 2020 with Cane Commissioner of Uttar Pradesh (Appropriate Authority) for an amount of ₹3847 lakhs as Capital Subsidy and for remission / exemption / reimbursement of taxes, duties and other charges aggregating of ₹5489 lakhs. The claim will be accounted for as and when it will be approved by the appropriate authority.
- d. Investment Promotion and Facilitation Agency of Government of Uttar Pradesh (INVEST U.P.) had issued letter of comfort on 12.01.2020 for grant facilities / relief under Industrial Investment and Employment Promotion policy-2017 (IIEPP-2017) and in accordance to which holding Company has accounted for and submitted claim of ₹ 108.75 lakhs on 19.02.2021 with PICUP which includes interest subsidy of ₹92.69 lakhs and ₹16.06 lakhs for GST/VAT refund. The matter is under process with INVEST U.P. for final disposal.

- e. The holding company has expanded capacity from 150 KLPD to 250 KLPD at plant situated at Village Barakatpur. Letter of comfort has been issued on 29.10.2024 under Industrial Investment and Employment Promotion policy-2022 (IIEPP-2022). Application of claim for capital subsidy of ₹ 500 lakhs filed on 18.02.2025, amount will be received in 10 years in equal instalments.
- Since the release of subsidy is dependent on the budget allocation of State Government it is recognized in the books of accounts in the year of receipt. During the year holding company has received a sum of ₹56.83 lakhs out of such subsidy as first installment which being the capital subsidy has been reduced from cost of the plant & machinery (refer note no.3 A)
- f. The holding Company vide letter no. 1 (4) /2025-SP dated 14.11.2025 received from, Government of India Ministry of Consumer affairs, Food & Public Distribution, Department of Food & Public Distribution is eligible for sugar export quota for 20406 MT. Out of above during the year has been swapped 15508 MT with domestic quota for ₹ 103.77 lakhs and 564 MT has been sold for ₹253.42 lakhs included in Revenue from Operations Note no. 24.
- Government of India Ministry of Consumer affairs, Food & Public Distribution, Department of Food & Public Distribution issued notification no. 16/ 2026-27 dated 13th May 2026 for export of sugar prohibited with immediate effect till September 30, 2026. However, holding company have further exported of sugar 273 MT during the F.Y. 2026-27.
- g. Previous year figures in consolidated statement in respect of subsidiary co. Uttam Distilleries Limited are for broken period from 30.07.24 i.e. date of becoming subsidiary to 31.03.2025.
- h. On November 21, 2025, the Government of India notified provisions 'Labour Codes' which consolidate twenty-nine existing labour laws into a unified framework governing employee benefits during employment and post-employment. The group had assessed the financial implications of these changes which had resulted in increase in gratuity liability arising out of past service cost by ₹135.05 Lakhs. Considering the impact arising out of an enactment of the new legislation is an event of non-recurring nature, the group has presented this incremental amount as "Impact of Labour Codes" under "Exceptional Item" in the Statement of Profit and Loss for the year ended March 31, 2026.
- i. Regulatory fee @ ₹20 per quintal of molasses sales / inter-unit transfers imposed by the State Government of Uttar Pradesh w.e.f. 24th December, 2021 has been accounted for under protest as the holding company has challenged the same and the matter is pending with Hon'ble Allahabad High Court.

- k. a. The Board of Directors of holding company has proposed a dividend on 6.50% Redeemable Preference shares and on 10% Redeemable Preference shares and ₹ 2.50/- per equity share of ₹ 10/- each, for the year ended 31st March 2026, which are subject to approval of Shareholders at the ensuing Annual General Meeting of the holding company.
- b. During the year the Board of Directors of the holding company has distributed a dividend for the year ended 31.03.2025 on 6.50% Redeemable Preference shares and on 10% Redeemable Preference shares aggregating of ₹ 90.13 Lakhs (Previous year ₹108.27 lakhs) and ₹ 2.50/- (Previous year ₹2.50/-) per equity share of ₹ 10/- each of ₹953.45 lakhs (Previous Year ₹ 953.45 Lakhs), after approval of Shareholders at the Annual General Meeting of the Holding company. o. The details of performance obligation in terms of Ind AS 115 - Revenue from contracts with customers are as follows:

Sugar:- The Sugar segment of the group principally generates revenue from manufacturing and sale of sugar and its by-products and power. Domestic sales of sugar are made on ex-factory/delivery basis in terms agreed to wholesaler /institutional buyers/merchant exporters within the country. Domestic sugar sales are majorly done on advance payment terms. Export sales of sugar to merchant exporters are done on ex-factory /delivered basis in terms of the agreement and revenue is recognized when the goods have been shipped to / delivered to the buyers' specific location. The sale price and payment terms is fixed as per contracted terms.

Power is supplied to distribution companies from the Group's facilities in accordance with the sale price, payment terms and other conditions as per the Power Purchase Agreements ("PPA").

Bagasse are sold generally on advance payment terms on ex-factory basis as per the terms of the agreement and revenue is recognized when the goods have been shipped to / delivered to the buyer.

Distillery:- The distillery segment of the group principally generates revenue from sale of industrial alcohol which mainly constitutes ethanol sold under contracts with Public and Private Oil Marketing Companies and other products to institutional buyers.

For sale of Ethanol, sale price is pre-determined based on Expression of Interest /Tender floated from Oil Marketing Companies. The prices are on delivered cost basis at Oil Marketing Companies locations inclusive of all duties/levies/taxes/charges etc. Payment terms is within 21 days after delivery of material and submission of original invoices.

Rectified Spirit, Extra Neutral Alcohol (ENA), etc. are sold on bulk basis to institutional buyers on ex-factory basis as per agreed terms. Revenue is recognized when goods have been shipped to the buyers' specific location as per agreed terms. The payment terms are fixed as per Group 's policy which are generally on advance payment basis.

Rajasthan State Industrial Development and Investment Corporation (RIICO), vide its order dated April 8, 2010, has cancelled the allotment of the plot allotted to the subsidiary company and later on demanded restoration and retention charges amounting to Rs 204.70 lakhs (Previous Year 204.70 lakhs) The group has filed a writ petition challenging the cancellation and demand of the restoration and retention charges, which is currently pending before the Hon'ble High Court of Jaipur. Pending settlement, the group has not provided for the amount in its financial statements and presently the payment made toward allotment to RIICO is appearing in Note no. 22.

As referred to in Note no. 36(c), due to an ongoing legal dispute with Rajasthan State Industrial Development and Investment Corporation (RIICO) pertaining to the distillery land, the project activities are hold under temporary suspension.

The Management is also hopeful for out of the court statement with Rajasthan State Industrial Development and Investment Corporation (RIICO).

Note No. 34 : Financial Risk Framework

The Group's financial liabilities comprise borrowings, capital creditors and trade and other payables. The main purpose of these financial liabilities is to finance the Company's operations. The Group's financial assets include Loans, trade and other receivables, cash and cash equivalents.

iii) Other risk

a) Regulatory risk

Sugar industry is regulated both by central government as well as by the state government, Central and state governments policies and factors such as State Advised Price (SAP) and fair and Remunerative Price (FRP) of sugar cane affects the sugar industry and the Group's operations and profitability. Distillery business is also dependent on the Government policy as the price of ethanol decided by the Government. Similarly sugar prices are also effected by the Government Policies like restriction on sale, import of sugar by way of allocation of monthly Quota, export of sugar and import duty / export duty determination of sugar and MSP of sugar.

The regulatory risks listed above are Government policy driven and are beyond the control of the group and can't be alleviated unless the industry is decontrolled. Various representation through the body of industry like ISMA, UPSMA and UPDA submitted to Government to come out solutions regarding above risks.

Power business is also dependent on the regulations prescribed by Central/State regulatory commissions. They fix power purchase rates and other guide lines for supply based on cost of bagasse and other inputs.

b) Commodity price risk

Sugar Prices in domestic and international markets depends primarily on the supply and demand situation. Fluctuation in demand and supply arise on account of the change in the availability and price of sugar variation in the production capacity of the competitor's availability of substitutes for the sugar products and international demand and supply position. The group has mitigated this risk by adding more value added products by diversifying into co- generation and distillation, thereby utilizing the by- products. Similarly, in sugar product also the company's products are diversifying in specialty sugar segments like brown sugar, sachet, pharma sugar, icing sugar, liquid sugar etc.

B. Credit Risk

Credit risk is the risk that counter party will default on its obligations under a Contractual arrangement leading to a financial loss. The group's sugar sales are mostly on advance payment basis. Power and ethanol are sold to state government companies and petroleum companies; thereby the credit default risk is significantly mitigated. Group has also taken advances and security deposits from its customers / agents, which mitigate the credit risk to an extent Financial assets are written off when there is no reasonable expectation of recovery, however, the group continues to attempt to recover the receivables. Where recoveries are made, these are recognized in the statement of profit and loss.
