The "Series-II" Preference Shareholder desirous to exercise vote by postal ballot may complete this Postal Ballot Form and send it to the Scrutinizer in the enclosed self-addressed postage prepaid reply envelope. Postage will be borne and paid by the Company. However, envelopes containing postal ballot form if deposited in person or sent by courier at the expenses of the Registered Preference Shareholder will also be accepted.
2. The holders of 10% Non-Cumulative Redeemable Preference Shares are entitled to cast their vote by filling, signing and completing the postal ballot form. Unsigned Postal Ballot Forms will be rejected.
3. The self-addressed envelope bears the name and postal Address of Scrutinizer appointed by the Board of Directors of the company.
